The Project consists of removing and recoating the interior and exterior of a 500,000-gallon elevated steel water tank and the replacement and installation of other related tank appurtenances. Bids will be received for a single prime Contract. Bids shall be on a lump sum basis as indicated in the Bid Form.

The Issuing Office for the Bidding Documents is Arcadis U.S., Inc. Prospective Bidders may obtain copies of the Bidding Documents from the Issuing Office via email request. Bidding Documents are available as portable document format (PDF) files).
