Given continued escalating raw material, packaging, and logistics costs, Eastman Chemical Company, through its subsidiaries, is announcing a price increase for its Turbo Oil, Skydrol[™], and Skykleen[™] products. The new prices will be effective starting June 1, 2021, or as contracts allow.

Effective June 1, 2021*, the following price increase will take effect:

In order to accomplish this, Eastman is establishing a sales control plan for all customers, where ratability is not specified in the commercial contract. This plan will cap monthly purchases for each customer ship-to location at 105% of their respective 12-month average monthly consumption. This sales control plan is effective immediately and will remain active until the new prices are in effect.
