

# Pre-Screening Students and Hybrid Scheduling Support with Safety iPass

### The Challenge

As schools across the country prepared for adapting their school safety protocols for COVID-19, Lisle Community Unit School District (CUSD) 202 in Illinois needed a way to provide a safe and healthy learning environment. The district was looking to create custom schedules for students to more safely allow a portion of the student population back to school for inperson learning.

## **The Solution**

Lisle High School initially chose CrisisGo to improve communication during school emergencies and lockdowns. With the unknown of the 2020-2021 school year, the district decided to utilize CrisisGo's Safety iPass to manage their certification and entry process and protect staff and students' health.

Safety iPass enabled Lisle CUSD 202 to:

- Create custom student schedules to accommodate all learning models.
- Provide a quick and reliable method to pre-certify staff and students.
- Safely and efficiently manage the entry process for in-person learning.

### The Results

Lisle CUSD 202 has been able to get students safely into the building in less than 30 minutes. Their check-in process begins at 8:00, and all students are in class for the first period by 8:30.

#### Jim O'Hara, the Dean of Students, explains:

"Safety is a priority...so having parents or guardians fill out [the precertification] and scanning kids' IDs as they came in to know they were certified before walking in was really nice...It's been very helpful because it is a process to get people into the building, and if we had individually asked every single student the questions and take their temperature as they came into our building, that would take a great deal of time that we wouldn't have in the morning."

Parents have found the process extremely easy. The administration sees Safety iPass as a reliable way to bring students back for in-person education while still keeping their community safe. It also fosters teamwork between parents and the administration: "The daily certification and having parents kind of be part of the team in helping us total those things out accurately has been very nice."

Overall, Safety iPass has been a great success at Lisle CUSD 202: "The nice thing about CrisisGo is that it is efficient, it is straightforward and effortless for parents, and for safety tracking purposes, it has given us a sense of relief in the morning."
