Hello AE Goetze Member,

We are excited to see you at the upcoming **Merger Meeting on June 28, 2021 at 5:30pm via Zoom**. This special membership meeting is being held because your credit union's Board of Directors approved a merger between AE Goetze Employees Credit Union and First Alliance Credit Union. As a member of the credit union you have been given the opportunity to vote to support your Board's decision.

You should have received your official voting ballot on May 7th; this ballot will need to be mailed-in using the green envelope and be received by June 28th to be tallied. At the upcoming meeting the results of the vote will be announced. Once the member vote is completed, both credit unions will work together with the MN Department of Commerce to finalize the details.

In the meantime, our team is excitedly preparing to welcome you and your fellow AE Goetze members into the First Alliance family! We understand you have questions about this exciting transition, and we will be sharing all the details with you over the coming weeks.

HERE'S WHAT WE KNOW SO FAR:

First, the official merger date will be July 1st, 2021, this is when AE Goetze and First Alliance will officially become one credit union. This is the day your AE Goetze account information will be merged into First Alliance's system. There may be limited access to your accounts leading up to this day to ensure a smooth transition, we will share more details when they become available.

Second, your branch will stay in the same location it is today at 201 North 8th Street in Lake City. After July 1st, however you will start to see more First Alliance branding at the branch and around town.
