



# COVID-19 Housing Stability Assistance Program

City of San Diego residents experiencing financial hardship because of the COVID-19 pandemic may qualify for help from the City of San Diego's COVID-19 Housing Stability Assistance Program.

This program will help qualifying households pay past-due, unpaid rent and utilities, as well as part of their upcoming rent, based on available funds. The program also will help pay past-due internet service expenses.

Per guidance from the U.S. Department of Treasury, financial help this program provides to a household is not considered income for the household.

The program does not ask about immigration status; it does not affect eligibility for the program.

The San Diego Housing Commission (SDHC) administers the program for the City of San Diego.

## Who Can Receive Help from the Program?

Households that meet the following criteria are eligible to receive help:

- Tenant has a City of San Diego address.
- Household income is at or below 80 percent of San Diego's Area Median Income (AMI), currently \$97,000 per year for a family of four. For the complete AMI chart, [click here](#).
- Household has an obligation to pay rent.
- Household does not currently receive any rental subsidies. (Households that receive rental subsidies can only apply for help with their past-due utilities. Assistance will depend on funding availability.)
- At least one member of the household has a reduction of income or other financial hardship due to COVID-19.
- Household experienced or is at risk of experiencing homelessness or housing instability.

Priority is given to these types of households:

- Income is at or below 50 percent of San Diego's AMI (\$60,600 per year for a family of four).
- At least one member of the household has been unemployed for 90 days and remains unemployed.

## Required Information and Documents

Applicants are required to upload and submit supporting documents as part of their online application.

## Payments

The program is required to give priority to paying past-due, unpaid rent.

The program can pay 80 percent of a tenant's past-due, unpaid rent for the period of April 1, 2020, through March 31, 2021, but only if the landlord agrees to waive the remaining 20 percent.

If a landlord does not agree to these terms, the program can pay 25 percent of the tenant's past-due, unpaid rent.

If funds remain available after past-due, unpaid rent payments have been made for qualifying households, the program can pay up to 25 percent of the tenant's upcoming monthly rent for April 2021 through June 2021.

Qualifying households also may receive help to pay past-due, unpaid utilities, such as electricity, gas, water and sewer, trash removal and energy costs, such as fuel oil. Telephone and cable are not eligible for utility assistance, and utilities paid by the landlord are considered rent.

Rent payments will be made by direct deposit to the landlord and utility provider. A check will be mailed for the rent if the landlord does not do business with a financial institution.

If a landlord declines to accept payment, the program will provide a payment to the tenant. Rent payments will equal 25 percent of the rent the tenant owes.
