MAS Overview – the Basics



- Governmentwide contract vehicle for <u>commercial</u> products, services, and solutions
- Also known as "Federal Supply Schedule (FSS)," "GSA Schedule" or "MAS"
 - VA manages Schedules for medical supplies and services they are called "VA Schedules"
- Standing <u>solicitation</u> posted on <u>beta.SAM.gov</u>
- Awarded using FAR Part 12 procedures



- Multiple Award IDIQ (5 year award, three 5 year options)
 - VA 5 year base, with one 5-year option
- Fixed Price EPA
- Fair and reasonable pricing
 - Price reductions may be applied at the order level
- Performance requirements established at the order level



Advantages of Multiple Award Schedules

- Saves time
 - Full and open competition has already been obtained
 - Publication on beta.sam.gov is not required for orders
 - Fair and reasonable prices have already been negotiated
 - Terms and conditions are already in place
- Buying activity receives socioeconomic credit
- Contract flexibilities:
 - Blanket Purchase Agreements (BPAs)
 - o <u>www.gsa.gov/bpa</u>
 - Contractor Team Arrangements (CTAs)
 - o <u>www.gsa.gov/cta</u>
 - Small business set-asides are permissible (discretionary)



GSA MAS Simplifies the Acquisition Process





In contrast to FAR Part 15, Schedule orders do <u>not</u> require:

- Formal evaluation (SSEB not required)
- Cost analysis (commercial pricing at the Schedule level)
- Extensive documentation (less formal process)
- Debrief (may provide brief explanation)
- Competitive range determination



Schedule users shall not:

Ø Seek further competition outside of the MAS program

Ø Synopsize the requirement

Ordering Procedures for Products FAR 8.405-1

EXCEEDS SAT

- The ordering activity contracting officer <u>shall</u> provide an RFQ that includes a description of the supplies to be delivered or the services to be performed and the basis upon which the selection will be made
- Develop the RFQ and post to GSA eBuy <u>or</u> provide the RFQ to as many schedule contractors as practicable to reasonably ensure that quotes will be received from at least three
 - (Document file if receive less than three quotes)
- Limited Sources Justification, if applicable
- <u>Shall</u> seek a price reduction (FAR 8.405-4)
- Best value determination
- May not place orders orally

MICRO-SAT

- Ordering activities shall place orders with the schedule contractor that can provide the supply or service that represents the best value
- Survey ≥ 3 contractors (GSA Advantage, Catalogs, Pricelists)
- Limited Sources Justification, if applicable
- Determine if a price reduction should be sought
- Best value determination

BELOW MICRO

- Ordering activities may place orders with any Federal Supply Schedule contractor that can meet the agency's needs
- Although not required to solicit from a specific number of schedule contractors, ordering activities should attempt to distribute orders among contractors



Ordering Procedures for <u>Services</u> Requiring an SOW FAR 8.405-2

MICRO-SAT

- The ordering activity shall develop a statement of work, and shall provide the RFQ (including the statement of work and evaluation criteria) to at least three schedule contractors that offer services that will meet the agency's needs
- Specify the type of order (*i.e.*, firm-fixed-price, labor-hour) for the services identified in the statement of work
- Limited Sources Justification, if applicable
- Determine if a price reduction should be sought
- Best value determination

BELOW MICRO

- Ordering activities may place orders with any Federal Supply Schedule contractor that can meet the agency's needs
- Although not required to solicit from a specific number of schedule contractors, ordering activities should attempt to <u>distribute</u> <u>orders among contractors</u>



Ordering Procedures for <u>Services</u> Requiring an SOW (cont) FAR 8.405-2

EXCEEDS SAT

- Each order shall be placed on a competitive basis unless waived on the basis of a limited sources justification
- The ordering activity contracting officer shall provide an RFQ that includes a statement of work and the evaluation criteria
- Provide the RFQ to as many schedule contractors as practicable to reasonably ensure quotes from at least three contractors
- When fewer than three quotes are received from schedule contractors that can fulfill the requirements, the contracting officer shall prepare a written determination to explain that no additional contractors capable of fulfilling the requirements could be identified despite reasonable efforts to do so. The determination must clearly explain efforts made to obtain quotes from at least three schedule contractors
- Ensure all quotes received are fairly considered and award is made in accordance with the evaluation criteria
- The ordering activity shall provide the RFQ (including the statement of work and the evaluation criteria) to any Schedule contractor who requests it
- <u>Shall</u> seek price reduction (FAR 8.405-4)
- Best value determination
- Overall price reasonableness determination (consider mix of labor and level of effort)
- May not place orders orally



EXCEEDS SAT

- Develop RFQ, including the basis of award
- Post to GSA eBuy OR provide to as many Schedule contractors as is practicable to ensure at least three quotes
- Limited Sources Justification, if applicable
- <u>Shall</u> seek price reduction (FAR 8.405-4)
- Best value determination

BELOW SAT

- Survey ≥ 3 contractors
- Limited Sources Justification, if applicable
- Determine if a price reduction should be sought
- Best value determination



EXCEEDS SAT

- Prepare SOW / PWS and establish evaluation criteria
- Specify type of order preference (FFP, T&M, LH)
- Limited Sources Justification, if applicable
- Post to GSA eBuy OR provide to as many as is practicable to ensure at least three quotes
- Shall seek price reduction (FAR 8.405-4)
- Best value determination

BELOW SAT

- Prepare SOW / PWS and establish evaluation criteria
- Specify type of order preference (FFP, T&M, LH)
- Issue RFQ to ≥ 3 contractors
- Limited Sources Justification if applicable
- Best value determination



Procedures for Ordering from Multiple-Award Schedule BPAs (FAR 8.405-3(c))

EXCEEDS SAT

- Issue RFQ to all eligible BPA holders, or follow procedure for limiting sources
- Select best value quote
- Document best value determination and evidence of compliance with ordering procedures

MICRO-SAT

- Provide fair opportunity to all BPA holders or document reasons for restricting consideration
- Select best value quote

BELOW MICRO

- Place order with BPA contractor
- Distribute orders among BPA contractors



Additional Procedures for Hourly Rate Services - FAR 8.405-3(c)(3)

- Ordering activity <u>shall</u> develop a statement of work for each order
- Ordering activities should place these orders on a firm-fixed price basis
- For T&M and LH orders, the contracting officer <u>shall</u> follow the procedures at FAR 8.404(h) (Requires D&F)
- All orders under the BPA <u>shall</u> specify a price for the performance of the tasks identified in the statement of work
- Ordering activity is responsible for considering the level of effort and the mix of labor to determine <u>overall price reasonableness</u>



- Discretionary small business set-asides are permissible under MAS
- 8.405-5(a)(2) Follow the ordering procedures at:
 - 8.405-1 Products and services without SOW
 - 8.405-2 Services with an SOW
 - 8.405-3 Blanket Purchase Agreements (BPAs)
- FAR Part 19 procedures do not apply



Limiting Sources (8.405-6)

Use of Limited Sources Justification

- Schedule orders may be awarded on a <u>sole-source</u> or <u>brand-name</u> basis, as required by the ordering activity.
 - Orders exceeding the SAT must have an approved Limited Sources Justification (LSJ).
- Posting requirements:
 - <u>Sole-Source</u>: post the approved LSJ at the government point of entry at <u>beta.SAM.gov</u> within 14 days after award and for a minimum of 30 days for requirements exceeding the SAT.
 - <u>Brand-Name</u>: Posting requirements begin at \$25,000 and must be posted in GSA eBuy with the RFQ.



MAS Consolidation Overview



BLUF (Bottom Line Up Front)

- No major impact on buyers throughout the consolidation process
 - No impact to existing orders no need to recompete or move orders
- Contract number did not change
- Period of Performance did not change
- Companies with more than one MAS contract will be consolidated to one contract in Phase III
 - Legacy Schedule contracts will remain in place until existing BPAs are cancelled or expired
- No SINs have been completely cancelled
 - SINs were consolidated from 881 to 317 NAICS based SINs
 - Review SIN Mapping Spreadsheet
- 12 Large Categories and 83 Subcategories
- Contractors must have the SIN awarded on their GSA Schedule in order to sell under it



- Reduces contract duplication and increases competition in the Federal marketplace
 - Contractors will be better able to offer all products and services on a single Schedule
 - Buyers will be better able to acquire products, services, and total solutions under the new NAICS-based SIN structure
- NAICS based SINs simplify scope determination and alignment
- One set of terms and conditions across the GSA MAS Program
 - Promotes more consistency in contracting practices
 - Easier process to view and understand contract terms and conditions
- Contractors will have a single point-of-entry for the GSA Schedule program





MAS Reform and OLMs <u>www.gsa.gov/olm</u>



- OLMs are supplies or services acquired in direct support of a task or delivery order placed against a GSA Schedule contract or BPA.
- OLM prices are **not** established on the Schedule contract.
- OLM prices **are** established at the *order level*.
 - The ordering contracting officer (OCO) is responsible for making a fair and reasonable price determination.
- Purchased under the authority of the FSS program FAR 8.403(b).
- OLMs shall not be the *primary* purpose of the order, but an integral part of the solution.
- OLM SIN may not be used as a stand-alone SIN, but may only be used to support other SINs on an order.

Under the GSA Consolidated MAS Schedule, OLMs are authorized to be acquired under 59 OLM-eligible <u>subcategories</u>*

*Contractors must have the OLM SIN awarded in order to provide OLMs on the order.

The OLM SIN description has been streamlined as follows:

OLMs are supplies and/or services acquired in direct support of an individual task or delivery order placed against a Schedule contract or BPA. OLM pricing is not established at the Schedule contract or BPA level, but at the order level. Since OLMs are identified and acquired at the order level, the ordering contracting officer (OCO) is responsible for making a fair and reasonable price determination for all OLMs.

OLMs are procured under a special ordering procedure that simplifies the process for acquiring supplies and services necessary to support individual task or delivery orders placed against a Schedule contract or BPA. Using this new procedure, ancillary supplies and services not known at the time of the Schedule award may be included and priced at the order level.

OLM SIN-Level Requirements/Ordering Instructions:

OLMs are:

- Purchased under the authority of the FSS Program
- Unknown until an order is placed
- Defined and priced at the ordering activity level in accordance with GSAR clause 552.238-115 Special Ordering Procedures for the Acquisition of Order-Level Materials. (Price analysis for OLMs is not conducted when awarding the FSS contract or FSS BPA; therefore, GSAR 538.270 and 538.271 do not apply to OLMs)
- Only authorized for use in direct support of another awarded SIN.
- Only authorized for inclusion at the order level under a Time-and-Materials (T&M) or Labor-Hour (LH) Contract
- Line Item Number (CLIN)
- Subject to a Not To Exceed (NTE) ceiling price

OLMs are not:

- "Open Market Items."
- Items awarded under ancillary supplies/services or other direct cost (ODC) SINs (these items are defined, priced, and awarded at the FSS contract level)

OLM Pricing:

- Prices for items provided under the Order-Level Materials SIN must be inclusive of the Industrial Funding Fee (IFF).
- The value of OLMs in a task or delivery order, or the cumulative value of OLMs in orders against an FSS BPA awarded under an FSS contract, cannot exceed 33.33%.


NOTE: When used in conjunction with a Cooperative Purchasing eligible SIN, this SIN is Cooperative Purchasing Eligible.

There has been no change in the underlying OLM Authority or Special Ordering Procedures for utilizing OLMs. The changes noted here are administrative in nature and were made as part of the overall Schedule Consolidation process.






