Directors

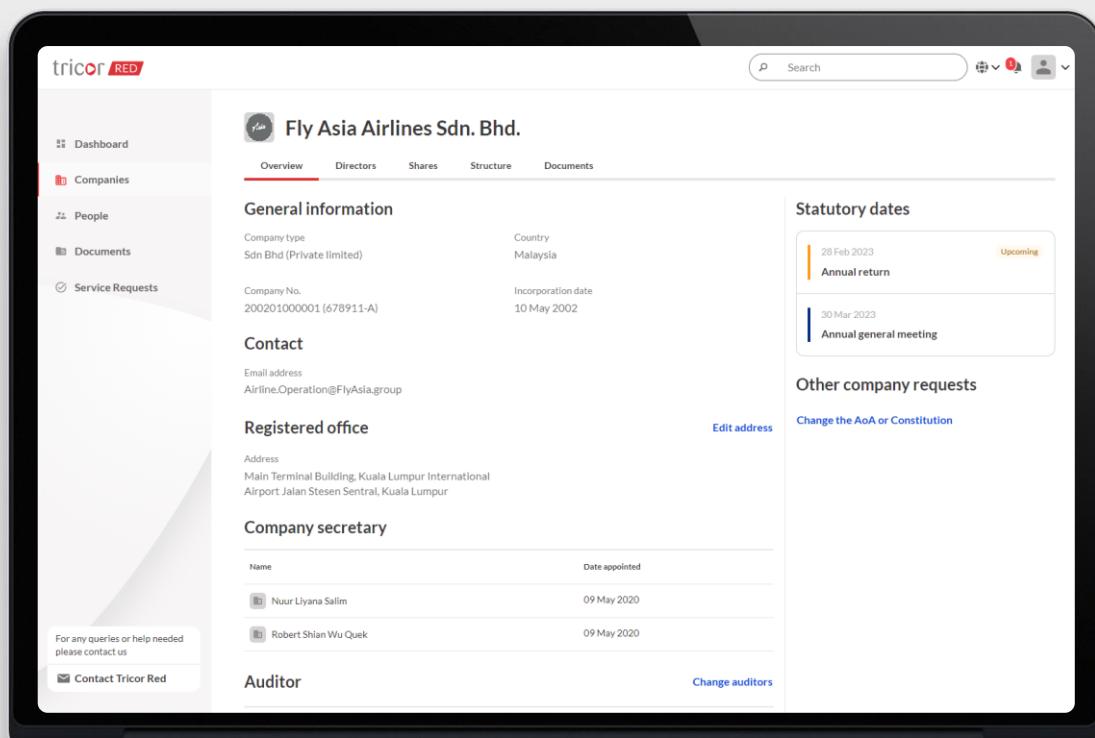
Contains the company's registered directors and associated date of appointment. Director's details can be clicked into.

Comprises the latest version of statutory documents related to the company.





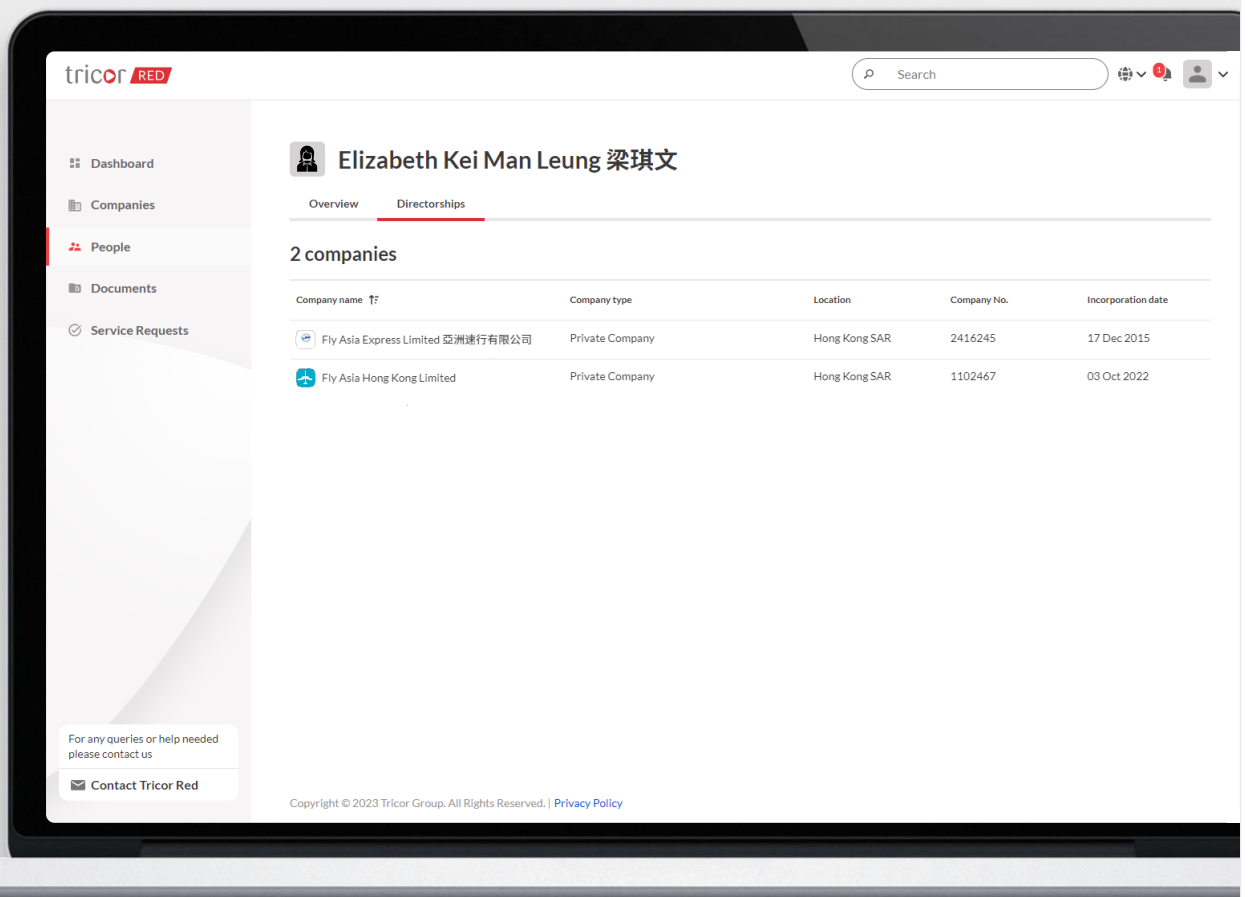
People view
