By the signature below, the party signing on behalf of the Applicant acknowledges having read and agrees to and intends to be bound by the online Enhanced Network Systems Standard Terms and Conditions of Sale, the Applicant’s purchase order, the Enhanced Network Systems, Inc., (“ENHANCED”), order confirmation or invoice, the Credit Application, which are the exclusive terms and conditions governing any and all sales and purchase transactions between ENHANCED and Applicant which shall not be modified in any way except by a writing signed by both ENHANCED and Applicant.

2. By submitting this application, Applicant authorizes ENHANCED to make inquiries into the banking and business/trade references supplied by Applicant. If Applicant pays the full purchase price before the product is shipped, Applicant need only complete Section A of the Credit Application.

3. Applicant’s signature affirms that all information contained on this Credit Application is true and correct. Applicant hereby makes application for credit and provides the information contained herein for the purpose of ENHANCED, a Colorado corporation, making periodic sales of goods on credit to the Applicant. In consideration thereof, it is agreed and understood that:

(1) The undersigned is an authorized agent of the Applicant and is duly authorized to enter into and make a binding agreement on the Applicant’s behalf. (2) Applicant authorized its creditors, above credit references, banks and financial institutions to release credit, banking and financial data to ENHANCED. (3) All payments shall be made to Enhanced Network Systems, Inc., 14 Inverness Drive East, Suite F-100, Englewood, CO 80112. (4) All past due accounts shall bear interest at the rate of 2% per month on the outstanding balance, or the maximum legal rate, whichever is higher. (5) Applicant agrees to pay \$25.00 for each check issued by Applicant to ENHANCED which is returned to ENHANCED for non-payment. (6) Applicant waives notice of default and demand for payment and agrees to pay all expenses of collection including reasonable attorney fees and related costs and any and all applicable interest thereon. (7) ENHANCED at its sole discretion may at any time amend, revised, or update the Standard Terms and Conditions of Sale, change payment terms, credit limit, or cease further extensions of credit to Applicant. (8) Delivery of all goods covered by this Agreement shall be F.O.B. ENHANCED’s warehouse. All risk of loss, damage or destruction shall pass from ENHANCED to Applicant upon transfer of possession to the common carrier. ENHANCED shall in no event be liable for any direct, indirect, special, incidental, consequential, or other damages suffered by Applicant due to delay in shipment. (9) The Colorado courts shall have jurisdiction to litigate any dispute between Applicant and ENHANCED, and any and all litigation shall be instituted and litigated in the State of Colorado. Applicant hereby waives any right to a change of venue or jurisdiction and hereby submits to and acknowledges the jurisdiction of Colorado.
