New Rate Provider for Currency Exchange Rate Integration

As an enhancement to the Currency Exchange Rate Integration feature, HSBC is now a currency exchange rate provider. HSBC is a global bank with expertise in multiple currencies. NetSuite offers the same methods, such as triangulation, for obtaining exchange rates from HSBC as from other rate providers.

When you enable the Currency Exchange Rate Integration feature for the first time, HSBC is the default rate provider. You can choose a different rate provider if you want to.

Advanced Numbering Duplicate Detection for Imported Transactions

NetSuite now supports duplicate document number detection for advanced numbering. When you import a transaction, NetSuite determines which numbering rule applies to it using your rules' criteria. Then, NetSuite checks if a transaction with the same document numbers already exists for the rule. If NetSuite detects a duplicate it takes one of the following actions, based on your Duplicate Number Warnings setting:

- **No Warnings** - NetSuite does not warn you when imported transactions use duplicate document numbers and imports all transactions.
- **Warn (UI Only)** - NetSuite warns you when imported transactions create duplicate document numbers and imports all transactions.
- **Warn and Block** - NetSuite warns you when imported transactions create duplicate document numbers, and does not import these transactions.

The behavior of these options when saving transactions in the UI is unchanged from previous releases.

To set up duplicate detection for imported transactions, go to Setup > Accounting > Preferences > Accounting Preferences > Items/Transactions > Other Transaction Preferences, and set the Duplicate Number Warnings preference.

Preference to Allow Non-posting Changes in Closed Periods by Default

NetSuite now includes a preference called Allow Non-GL Changes Is Set by Default to allow non-posting changes in closed periods by default. When set, NetSuite checks the Allow Non-G/L Changes box for each new accounting period you create. Accounting periods created before setting this preference remain unchanged.

In this release, you can also check or clear the Allow Non-G/L Changes box on all accounting periods, including unlocked periods.

Enhancement to Accounting Book Visibility by Role

This release includes updates to how you select which accounting books are accessible to users by role. Users with a role that gives them access to an accounting book can post transactions to that book or see reports from that book.

With this updated functionality, you can grant a role access to all accounting books, and users with this role can automatically access new accounting books.

To set this preference by role, go to Setup > Users/Roles > User Management > Manage Roles. For each role, you can select one of the following options from the Selected Accounting Books field:

- **All** - This role can see all accounting books
- **Primary** - This role can see only the primary accounting book
- **Primary and Selected** - This role can see the primary accounting book and any secondary books you select. When you select this option, an Accounting Book field appears, and you can select which secondary books the role has access to.

New Sandbox Refresh Options for Non-standard Service Tiers

If you are on a Premium, Enterprise, or Ultimate service tier, your sandbox refresh options are expanding. Each of your sandbox accounts has the option to be refreshed from either your production account or another sandbox account. The account where the data is copied from is referred to as the source account. Refreshing a sandbox account copies all configurations, data, user passwords, and customizations from the source account into the target sandbox account.

You cannot copy data from the following types of accounts:

- The sandbox account you are trying to refresh
- Sandbox accounts not associated with your production account
- Sandbox accounts with expired licenses
- Sandbox accounts that are inactive

 **Note:** Source accounts that are actively being used as a refresh source will be disabled in the dropdown list until the refresh completes.

Core Administration Permissions Feature Enabled by Default

By default, the Core Administration Permissions feature is now enabled on all accounts. Core Administration Permissions is a feature that can be enabled for a role and gives the role access to a functionality that is currently only accessible to the standard Administrator role. You can use Core Administration Permissions to customize a role so that it behaves almost like the Administrator role, while also restricting access to other areas of NetSuite using role permissions and restrictions. You can assign Core Administration Permissions to any role, by checking the Core Administration Permissions box.

Enhancements to NetSuite OAuth 2.0 Support

NetSuite 2021.2 introduces the client credentials flow, a new type of OAuth 2.0 flow, and provides updates to the consent screen.

In addition, the consent screen is now designed for better readability and easier use. The **Allow/Continue** button is now highlighted.

OAuth 2.0 Client Credentials Flow


As of NetSuite 2021.2, you can implement the OAuth 2.0 client credentials flow. The standard OAuth 2.0 client credentials flow has one step and does not require any user interaction.

To use the OAuth 2.0 client credentials flow, the Administrator must check the **Client Credentials Grant (Server-To-Server)** box in the integration record. The Administrator must also register the public key with the integration, and the account. Every integration-account pair must have its own public key.

There is no user interaction during the OAuth 2.0 client credentials flow. The Administrator gives consent automatically when the flow initiates. It is possible to manually revoke the consent to invalidate the access token for an integration.

Request to the token endpoint in OAuth 2.0 client credentials flow consists of two steps:

- An application sends the request parameters for authentication.
- If the request is successfully authorized, the system issues an access token, valid for 60 minutes. There is no refresh token. The application must authenticate again after the access token expires.

 **Note:** The use of public clients is not supported for the OAuth 2.0 client credentials flow.


Updated Consent Screen Design

You can now choose how often a consent screen displays during the OAuth 2.0 authorization code grant flow.

There is a new field on the integration record, where you can choose to always display the consent screen, never display it, or display it the first time only. See the following for more details about these options:

- **Ask always** - This is the default option. The consent screen displays every time the OAuth 2.0 code grant flow is initiated.
- **Ask never** - The consent screen does not display during the OAuth 2.0 code grant flow. The integration is autoapproved by the Administrator.
- **Ask for the first time** - The consent screen only displays the first time the OAuth 2.0 code grant flow is initiated. The consent screen also displays if any of the following is true:
 - The consent was not given previously
 - The system does not know which role or account to choose for the user to log in with
 - The application requires a different set of scopes and needs a new consent

Integration developers can adjust the consent screen options using the prompt parameter in Step One of the OAuth 2.0 code grant flow.

 **Note:** If there is no active NetSuite session, the user must authenticate even if the consent screen does not display. If there is no active session, the user is redirected to the NetSuite login form or to an identity provider's login form.

End of Support for HMAC-SHA1 Signature Method for TBA Postponed

The end of support for the HMAC-SHA1 signature method for the Token-based Authentication (TBA) feature has been postponed. Previously, the end of support was targeted for NetSuite 2022.1. The new target date for the end of support will be announced later. Even though the end of support has been delayed, you should update your integrations to use HMAC-SHA256 as soon as possible.

After the end of support, any integrations using the TBA feature with HMAC-SHA1 as a signature method will stop working. The end of support and the request to change the signature method to HMAC-256 also applies to third-party integrations.

You must use the HMAC-SHA256 signature method to create new integrations for use with TBA.

Before the end of support, you must update your authorization header to use HMAC-SHA256. To update the authorization header, change the values of the `oauth_signature_method` parameter and the `oauth_signature` parameter to HMAC-SHA256.

Important: If you are using a library for signing, verify that the library supports HMAC-SHA256, and if needed, update to a library with HMAC-SHA256 support.

Enhancements to the SAML Single Sign-on Service Provider-initiated (SP) Flow for Web Store

As of 2021.2, the SAML Single Sign-on feature for web store setup is enhanced. It is now possible to make SAML SSO a primary authentication method for SAML SSO on the SAML SSO for web store setup page. To make SAML SSO the primary authentication method, check the **Primary Authentication Method** box on the setup page. By checking the box, you choose the service provider-initiated flow to be used for your web store.

- By default, the **Primary Authentication Method** box is not checked for new web store setup. If you used the SAML Single Sign-on feature for web store before, the box is checked by default. If SAML users click a link to access NetSuite when no active NetSuite session exists, they are redirected to the NetSuite login page. This redirect might cause issues for users who do not know their NetSuite credentials.
- If the Administrator checks the **Primary Authentication Method** box, users can be redirected to the external IdP login page. This redirect is available if:
 - The user has already logged into NetSuite, and the redirect occurs based on previous experience with NetSuite
 - The access link identifies the web store by a web store-specific domain URL.
 Users will be redirected to the IdP login page when the session times out.



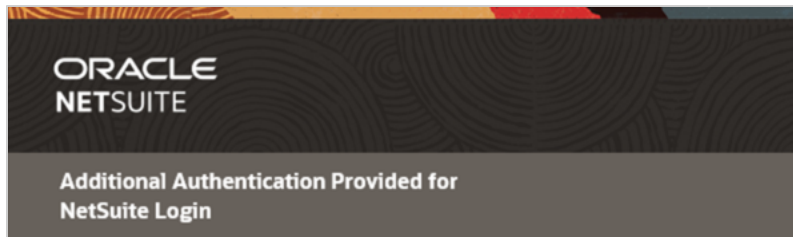
Note: If the **Primary Authentication box** is checked, and a user clicks a link containing the `c` or `compid` URL parameter or the account-specific domain URL, the user is redirected to the external IdP login page. The originally requested URL is passed as a RelayState parameter, in accordance with the SAML 2.0 specification. As a result, the IdP can direct the user back to the correct NetSuite resource after authentication. If there is a live session for the IdP, the user is redirected back to the NetSuite resource without being asked for credentials.

New Look for NetSuite Authentication Email Messages

NetSuite system-generated email messages related to authentication, including messages about password expiration, password reset, and security questions, have a new look. This new design is intended to provide better readability.

The following image is an example of the header for redesigned authentication messages.



Both users and administrators will see the new look in authentication-related email messages.

Create Your Own Test Window for HMAC-SHA1 in TBA Integrations

As of NetSuite 2022.1, the HMAC-SHA1 signature method for Token-based Authentication (TBA) integrations will no longer be supported, and any integrations still using it will stop working. To help you prepare for the end of support, you can temporarily disable the HMAC-SHA1 signature method for TBA in your production account. Disabling HMAC-SHA1 temporarily allows you to test your TBA integrations to verify that they are not using the HMAC SHA1 signature method.

Note: Support ended on July 30, 2021 for the HMAC-SHA1 signature method for TBA integrations in all non-production accounts, such as sandbox, test drives, development accounts, and Release Preview accounts.

To temporarily disable HMAC-SHA1 for TBA in your NetSuite production account:

1. Go to Setup > Company > Setup Tasks > Enable Features.
2. Click the **SuiteCloud** tab, and scroll down to the Manage Authentication section.
3. Check the **Disable HMAC-SHA1 for Token-based Authentication** box.

To re-enable HMAC-SHA1 for TBA, clear the Disable HMAC-SHA1 for Token-based Authentication box.

Important: You must update any TBA integrations to use HMAC-SHA256 for the signature method before the end of support in NetSuite 2022.1. Accounts will be upgraded to 2022.1 between February and April of 2022.

Automated Cash Application

You can import bank lines that do not have matching customer payments in NetSuite. The Automated Cash Application feature lets you automatically generate a batch of general ledger customer payments in NetSuite and apply them to open invoices. If you receive a high volume of customer payments daily, this feature helps you apply them to open accounts receivable accounts in bulk.

You can automate cash application at Transactions > Bank > Automated Cash Application. Alternatively, if you are matching transactions on the Match Bank Data page and want to automatically generate customer payments, click **Automated Cash Application** in the top-right corner. For permission details, see the help topic [Permissions for Banking Features](#).

The Automated Cash Application feature enables you to do the following:

- View all imported bank lines with a positive amount that are not matched with a corresponding account transaction. If you match an account transaction on the Match Bank Data page, the corresponding imported bank line no longer appears on the Automated Cash Application page.
- View the name of the customer to which each imported bank line belongs (or possibly belongs). The system can automatically assign a customer to a bank line using an exact match, partial match, or preferred match. If no match is achieved, you can select a customer. See the help topic [Customer Match Criteria](#).
- Create customer mapping rules that the system can remember and use to map customers to future incoming bank lines. See the help topic [Adding or Changing a Customer](#).
- View the invoice or invoices to which a payment will be applied. If the imported bank line does not specify an invoice number, NetSuite provides a list of suggested invoices to which the payment can be applied. See the help topic [Reviewing Invoices for an Imported Bank Line](#).

The system makes invoice suggestions based on the **Apply Payments Without Invoice Numbers** preference. See the help topic [Setting Accounting Preferences](#).

- View the payment amount applied to each invoice. The system automatically allocates payment amounts to invoices, taking into consideration whether the invoice is pre-allocated in other payments. You can adjust applied amounts on each invoice.

Bulk Matching

The Match Bank Data page now includes a **Select All** box. This box lets you check or clear all the boxes for all items visible in the current page of the Account Transactions grid.

The bottom section in which selected items from the grids appear, and the popup windows for viewing matched or cleared transactions, are now paginated. Consequently, you can find transactions with limited scrolling. For large numbers of transactions, pagination can help improve performance, because the browser does not have to display all selected transactions at once.

The **Number of Rows In List Segments** preference determines how many rows the bottom section can display per page. Each page can display a maximum of 500 rows at a time.

Automatically Clear Held Transactions

Previously, when migrating a held statement from the original reconciliation pages to the redesigned pages, you had to clear all transactions on the Match Bank Data page.

Note: A held statement is one you have begun to reconcile but have chosen to complete later.

Ability to use Machine Learning to Calculate and Display Product Recommendations



Important: Intelligent Item Recommendations are available only for accounts that meet specific criteria. For more information on the current criteria, see the help topic [Account Requirements for Intelligent Item Recommendations](#).

If Intelligent Item Recommendations are not suitable for your account, the feature will not be available to select on the Enable Features page.

The Intelligent Item Recommendations feature uses artificial intelligence algorithms to calculate and display items a shopper may be interested in buying. The algorithms use data such as:

- what the shopper bought in the past
- what other shoppers with similar transaction history bought in the past
- what other items were bought by customers who bought a specific item

Two types of intelligent recommendations are available:

- **“For Shopper” recommendations** - often called “You might like” recommendations, these are specific to each shopper and are based on the shopper’s purchase history and items bought by shoppers with a similar purchase history.
- **“For Item” recommendations** - often called “Customers who bought this also bought” recommendations, these are specific to each item and are based on the purchase history of other shoppers who bought the selected item.

To use intelligent recommendations, you must first enable the feature and install and activate the Intelligent Item Recommendations extension. After this, you can create recommendation scenarios, if needed.

Recommendation scenarios are a set of configuration guidelines that the machine learning algorithm follows while calculating which items to recommend. Each recommendation scenario applies to a single website and recommendation context (For Shopper or For Item). When you enable intelligent item recommendations, NetSuite creates a default recommendation scenario for each website and recommendation context. The default scenarios are suited to most businesses but you can modify them or create your own scenarios, if needed.

The guidelines defined in a recommendation scenario include:

- **Website** - the website on which this recommendation scenario is to be used.
- **Recommendation context** - whether the scenario is for use in a For Item or a For Shopper recommendation context.
- **Freshness** - the degree to which the recommendations should prioritize items recently added to the website.
- **Novelty** - the degree to which the recommendations should prioritize items that shoppers rarely see.
- **Diversity** - the degree to which the recommendations should prioritize items that are different from each other.

You can then use Site Management Tools (SMT) to add the Recommended Items content type to your website. You can add multiple Recommended Items content types to your website. For Shopper recommendations can be added anywhere in the website, for example to the home page or the checkout page. For Item recommendations can be added only to product display pages. When you add a Recommended Items content type to your website, you can select the recommendation scenario you want to use.

After intelligent item recommendations are live on your website, the machine learning algorithms process and learn from the transaction data periodically and the recommendations shown to shoppers regularly change and improve.

New Payment Link Feature

The Payment Link feature allows your customers to pay an invoice quickly and easily online, using a computer or mobile device. Instead of having to contact you and discuss payment, your customers can receive an email of the invoice with a link to the payment page. They can choose which method they want to use to pay, including credit cards and PayPal, from a list you have selected.

This is a NetSuite feature that can be used in conjunction with SuiteCommerce and SuiteCommerce Advanced. To use this feature, you must enable Payment Link in your company preferences. Before Payment Link will work with your store, you must ensure that you have enabled Payment Instruments and completed all tasks on the setup checklist, such as setting up your payment methods and invoice templates.

Once you have enabled the feature, you can configure Payment Link to select certain payment methods, allow partial payments, and include a company logo and information. You can also customize the email templates that are used to inform customers when payment is accepted or rejected.

After setup is complete, you can offer customers an easy and convenient way to pay invoices from a link or QR code in an email. On the Payment Link Checkout page, a customer can review the invoice, choose a payment method, and submit payment.

Ability to Hide +1 Country Calling Code for Countries Using this Prefix

As of NetSuite 2021.2, you can hide the +1 country calling code in phone numbers if you comply with both of the following requirements:

- You use the Worldwide Support for Phone Number Formatting feature.
- Your company is located within a country that uses the +1 calling code.

The +1 calling code is used in the USA, in Canada, and in certain Caribbean, Caribbean Dutch, and British Overseas Territories.

SDF Support for Translation String Validation

As of NetSuite 2021.2, SDF supports two new types of validation for translation strings: length and uniqueness.

SDF validations are performed on translation strings linked to translatable fields, such as custom list names. These validations occur during installation of SuiteApps that include these translatable fields. These validations verify that the length of strings does not exceed translatable field limits and that each string is unique.

The uniqueness is validated by checking the values of translation strings in the default language of the account against:

- Other fields in the account
- Translation strings in the SuiteApp itself

For a translation string to pass the validation check, there cannot be any translation strings with the same value in the account or in the SuiteApp. If the validation conditions are not met, an error message occurs.

Earliest Item Availability

The Supply Allocation Earliest Item Availability page computes item and location level availability information based on simulated allocations. The system then displays the computed availability date for each location to provide answers to item availability inquiries regarding future demand.

Earliest Item Availability is now compatible with Sales Channel Allocation. This improves the earliest availability accuracy by limiting the calculation to allocate supplies set aside for sales channels.

To access Earliest Item Availability, go to Transactions > Order Management > Earliest Item Availability.

Optimize Allocation for Gross Profit and Revenue

Supply Allocation Optimizing Fill Rate provides a new method for delivering short-term supply allocation results, such as sales revenue or sales profitability. This new feature includes the following fields:

- **Using Revenue Optimization on Sales Order** – The system allocates existing supply to maximize sales revenue.
Revenue is the income on the sales transaction after the product is sold (invoiced). Sales order line revenue is stored in the Amount field, in the transaction currency.
- **Using Gross Profit Optimization on Sales Order** – The system allocates existing supply to maximize sales profits.
Gross Profit is the remaining sales transaction amount after you deduct direct item costs from revenue. Gross profit is calculated on the sales order line and stored in the Est. Gross Profit field, in the transaction currency.

Both the gross profit and the revenue allocation optimization compute allocations to maximize the sum of gross profit or revenue on the selected sales order lines.

Allocate Sales Orders

When supply allocation preferences are not set to immediate allocation after order entry, a new Allocate button appears on Sales Order forms. This new feature enables you to allocate sales orders in the correct order, after you enter data. This can help you to secure the allocation of some sales orders before running the Allocate Orders or Order Allocation Schedule processes.

Quantity Remaining Field for Order Reservation

A read-only Quantity Remaining field appears on the Order Reservation page. This field displays unallocated item quantities. This information can help you to decide how many more items you need to reserve. For more information, see the help topic [Working With Order Reservations](#).

Allocated Order Number Link

The number displayed in the Sales Order, Items subtab Allocated Supply or Allocated Demand order column now provides a link to the new Allocated Order popup window. You can use this feature to

navigate between demand to supply to learn whether other demands are allocated to the source of supply and which supplies are allocated to demand.

Available Date Calculation Fill and Kill

The Allocation Strategy Available Date Calculation option supports "Fill and Kill" order management scenarios. This feature enables you to fulfill orders that need to be shipped immediately with whatever quantity is available and then the system closes it.

You can clear the Commitment Confirmed box and reallocate the items. However, NetSuite WMS does not update the quantities on the associated wave transaction and its pick tasks. On your mobile device, you should pick only the remaining committed quantities, which you can partially fulfill. Do not pick the entire quantity on the released wave without replenishing the committed quantities on the order transaction. NetSuite WMS generates fulfillments for committed quantities only.

Delta Charges

A new Global Invoicing Accounting preference is now available that gives you improved flexibility when you need to bill for changes to invoiced service periods. To set this preference, go to Setup > Accounting > Invoicing Preferences. On the Subscription Management subtab, check **Create Delta Charges for Changes to Invoiced Service Periods**.

After you set this preference, if changes to invoiced service periods change what the customer owes, the system generates a Delta charge. The amount on a Delta charge is the difference (plus or minus) between the invoiced amount and the new amount for the service period. After the system generates the first Delta charge, you cannot turn off Delta Charges.

For example, you create an invoice of \$1000 on January 1 for an annual recurring service with monthly proration. On July 1, a Modify Pricing change order increases the quantity from 1 to 2. The following chart shows you how setting the **Create Delta Charges for Changes to Invoiced Service Periods** preference simplifies the billing for this change:

1/1-12/31	\$1000.00 (\$1000.00)	\$1000.00

Dataset Linking in SuiteAnalytics Workbook

Link datasets to analyze metrics from two datasets in a single visualization, based on a link that you define using common field data from each dataset. Unlike joining record types, you can link datasets even if they are based on record types that do not have predefined common keys in the analytics data source.

Additionally, with linked datasets you can compare data that exists on two different levels of aggregation, such as the sum of individual transactions versus a monthly budget.

In 2021.2, you can define your own linked datasets using the `N/datasetLink` module in SuiteScript. You currently cannot view or edit how datasets are linked from the Workbook user interface. However, you can save and share workbooks that are based on linked datasets or create new visualizations within them. Link definitions are also associated with the workbooks where they are created. This association means that you can use linked datasets in multiple visualizations, but only in the workbook where they were linked.

Mexico Bill of Lading (Complemento Carta Porte) SuiteApp version 1.0.0 enables your companies in Mexico to generate and process e-documents with a bill of lading.

The SuiteApp is generally available and can be installed from the NetSuite SuiteApp Marketplace (Application ID: com.netsuite.mexicocartaporte). It is a public and managed SuiteApp.

Mexico Bill of Lading (Complemento Carta Porte) provides the following features and capabilities:

- **Bill of Lading for Transfer CFDIs (Item Fulfillment Transactions)** – You can add a bill of lading to your transfer Digital Fiscal Document through Internet (CFDI or Comprobante Fiscal Digital por Internet de traslado) when they come either from a sales order or a transfer order. Income Statement Close Support

When the Period End Journal feature is enabled in your NetSuite account, you can include period end journals in the opening balance calculations and general ledger entries of the Norway Standard Audit File for Tax (SAF-T). To do this, you need to enable the **Income Statement Closing Entries** preference for the Norway nexus on the Country Tax Report Preferences page. This preference is available on the Tax Audit Files Data Filters subtab of the Norway nexus.

If you leave the **Income Statement Closing Entries** box cleared, the dynamic close is used instead. Opening balances of Profit and Loss accounts at the beginning of every accounting year are moved to the Retained earnings account.

Display Employees as Suppliers

Usually, the SAF-T report sources the SupplierID tag from the vendor record. However, some transaction types applied to A/P accounts and linked to an employee (like expense reports or journal entries) are being sourced from the employee record instead. In the latest version of the Norway Tax Reports SuiteApp, you now have the option to display such employee data in the SAF-T report. To do this, click the **Setup Norway SAF-T** button on the Country Tax Reports page, and in the **Allow displaying employees as suppliers** dropdown list, select **Yes**.

Set Account Mapping Type

Previously, the SAF-T report simultaneously uses two elements to display mapping: Standard Account ID and the combination of Grouping Category and Grouping Code. In the latest version of the Norway Tax Reports SuiteApp, this behavior is changed to reflect the requirements of Norway audit authorities.

You can now select the mapping category applicable to your company. To do this, click the **Setup Norway SAF-T** button on the Country Tax Reports page and select a value in the **Account Mapping Type** list. This setting overrides any account-specific data. The account mapping type that you select determines the mapping category that will be used in the report:

- If you select **2-digit Financial Standard Accounts** or **4-digit Financial Standard Accounts**, the Standard Account ID is used (and the Grouping Category and Grouping Code are not shown).
- If you select **RF-1167 Income Statement**, **RF-1175 Income Statement**, or **RF-1323 Income Statement**, the Grouping Category and Grouping Code is used (and the Standard Account ID is not shown).

Minor Enhancements to Norway Tax Reports

The latest version also contains the following minor enhancements for the Norway Tax Reports SuiteApp:

- SupplierID and CustomerID tags are only populated and exported on account payable and account receivable type accounts.
- Non-posting and statistical account type accounts are no longer exported and used in the audit file. Also, they are not validated for missing account numbers (which means that you do not need to map these accounts to successfully generate the SAF-T report).
- Tax groups containing one tax code are supported. If you assign a tax group (instead of a tax code) that contains a single tax code to a transaction, this one code will be shown in the report. However, if you use a group with multiple tax codes, the value in the audit file will be NA (not applicable).
- For the tax codes with a notional tax code assigned to them, the VAT rate is based on the tax rate of the notional tax code (instead of the standard tax code).
- Sourcing for the description tags AccountDescription (under General Ledger Accounts) and TaxCodeDetails > Description (under Tax Table) has been adjusted. Descriptions from the customer accounts and tax codes in NetSuite are now used, instead of the standard (tax authority) descriptions.
- The Master Files section of the report now includes the tax codes based on their validity dates.

Philippines Localization Support for BIR Simplified System Registration for CAS Users

Starting 2021, the Bureau Internal Revenue (BIR) will issue an Acknowledgement Certificate to companies or businesses that registered and submitted complete documentary requirements for using Computerized Accounting Systems (CAS).

This change is supported by the invoicing features of the Philippines Localization SuiteApp. In version 2.0.0, you can select the CAS document issued to your company by the BIR in the new Philippines Localization Setup page. The CAS document selected will be indicated in the footer details of your transactions that use Philippines invoicing templates. In the **BIR Document Issued** field, you can select **PTU** for Permit To Use or **AC** for Acknowledgement Certificate. You can also enter details such as the AC control or PTU number, date issued, and valid until date for the CAS document that you selected.

Subscription Billing Bulk Change Orders

 - Active to Suspend
 - Suspend to Reactivate

For status changes related to activation, suspend, or reactivate change orders, you must specify the details of the change order such as effective date, requester, modification type, and memo. For activation, you can request an off-cycle invoice for advanced charges.

SuiteBilling Enhancements version 21.2 also includes the following enhancements for bulk operations using mass update:

- **Void Records for Usage** – Previously, a **Delete Records** mass update action was available for deleting erroneous or obsolete usage records. Starting version 21.2, the **Delete Records** action is changed to **Void Records**, and the processed records are now voided instead of deleted.

The Pack Station mobile app is available in the Pack Station SuiteApp, which is shared with accounts that use NetSuite WMS. For non-WMS accounts, ask your NetSuite account manager about licensing requirements.

In NetSuite 2021.2, you can reuse pallets in another packing session, until you ship them. Orders on the same pallet must have the same shipping method and carrier. On the new Packing Details page, you can view the packed carton and pallet details. If you use the Warehouse Management feature, you can switch to the NetSuite WMS mobile app to ship your packed pallets.

If you configure your UCC company prefix or DUNS number, you can now generate GS1 linear bar codes for serial shipping container codes (SSCC-18). You can print carton and pallet lists with the SSCC-18.

Pack Station provides new system rules, as follows:

- **Allow real-time packing updates to fulfillments** – Lets you update fulfillment records and custom fields on order transactions in real time. You can specify a limit, from 1 to 75 fulfillment lines, to replace the default limit of 25 lines. When you submit orders for packing, real-time updates apply to fulfillments that do not exceed the limit.
- **Autogenerate carton and pallet IDs** – Enables you to autogenerate carton and pallet IDs based on a format that you define or the order number. On a kiosk device, you can view the autogenerated ID of a new carton or pallet.

Bundle support during phasing of 2021.2 is consistent with the support provided during previous releases. During phasing of 2021.2, some accounts continue to use 2021.1 at the same time that other accounts are upgraded to 2021.2. Therefore, you may be using a different version than some of the accounts where your bundles are installed.

Review the following descriptions for a reminder of how bundles from different versions are handled during release phasing:

- Bundles developed with 2021.1 can be installed in accounts that are already using 2021.2.
- Bundles developed with 2021.2 can be installed in accounts that are still using 2021.1, but with the following limitations:

Improved Security for Storing Custom Password Field Values

As of 2021.2, the SuiteScript 1.0 [nlapiEncrypt\(s, algorithm, key\)](#) default encryption method is no longer supported when used to check custom password fields. In addition, SuiteScript 2.x [Record.getValue\(options\)](#) and [CurrentRecord.getValue\(options\)](#) methods are no longer supported for custom password fields.

You can use the SuiteScript 1.0 [nlapiCheckPasswordField\(type, id, value, field, sublist, line\)](#) function or the SuiteScript 2.x [crypto.checkPasswordField\(options\)](#) method to check and validate values in custom password fields. In SuiteScript 2.x, if you continue to use [Record.getValue\(options\)](#) or [CurrentRecord.getValue\(options\)](#) on custom password fields, the value will no longer be returned as a hashed value, but will be obfuscated instead. For this reason, you should use the [crypto.checkPasswordField\(options\)](#) in your SuiteScript 2.x scripts. For more information, see the help topic [crypto.checkPasswordField\(options\)](#).

Update your scripts to use the new SuiteScript `checkPasswordField` APIs. For more information, see SuiteAnswer 96720: [Upcoming Changes to Supported APIs for Checking Custom Password Fields](#).

New Locale Parameter for Numbers in Advanced Printing Templates

A new parameter is available for the `nsformat_number` formatting method. The new parameter enables you to specify the locale to use to format the value of a numerical field. This parameter overrides the locale of the logged in user for the specific field only. You can set this parameter in the source code only.

The format of the new parameter is `${nsformat_number(record.field, "xx_XX")}`, where `record.field` represents the field and `xx_XX` represents the country locale code. For example, use `${nsformat_number(item.quantity, "cs_CZ")}` to format the Quantity field according to Czech Republic standards.

If the locale code is valid, the results are formatted according to the locale specified. If the locale code is invalid, the formatting defaults to use `en_US` (U.S. English). If the locale value is null or empty, the formatting defaults to use the locale of the logged-in user.

Installation Preferences Configuration Updates

SDF SuiteApp installation preferences have been updated with the following enhancements:

- You can now configure installation preferences for custom record types and custom lists in addition to script deployments.
- When an SDF SuiteApp is installed (or an SDF project is deployed), you can choose to preserve some or all of the existing data in the target account for script deployments, custom record types, and custom lists. Preserving data can be useful when you do not want to overwrite values your SuiteApp users have modified in the target account, such as script deployments, custom record instances, or custom list values.

You can configure SDF SuiteApp installation preferences by editing the code block `<preference type="OVERWRITING">` in the `overwriting.xml` file, which is located in the `InstallationPreferences` folder of your SDF project.

The following information describes the fields you can set for SDF SuiteApp installation preferences:

- For script deployments, you can set the following preferences:
 - For the `scriptdeployments` field, you can set the `defaultAction` attribute to `OVERWRITE` or `PRESERVE`. This setting is the default applied to all script deployments that are not explicitly set by the `scriptdeployment` field's `action` attribute.
 - For the `scriptdeployment` field, you can set the `action` attribute to `OVERWRITE` or `PRESERVE`. This setting applies to a specific script deployment.

The following code sample configures an SDF SuiteApp's installation preferences to overwrite all script deployments in the target account by default, with the exception to preserve the script deployment `customscript_user_event_example.customdeploy_ue_example`:

 - For the `instance` field, you can set the `action` attribute to `OVERWRITE` or `PRESERVE`. This setting applies to an individual custom record type instance.

The following code sample configures an SDF SuiteApp's installation preferences to preserve all of the instances for custom record type `customrecord_type_example` in the target account by default, except for the instance `customrecord_instance_example` which will be overwritten:

- For the customvalue field, you can set the action attribute to OVERWRITE or PRESERVE. This setting applies to an individual list value.

The following code sample configures an SDF SuiteApp's installation preferences to overwrite all of customlist_example custom list's values in the target account by default, except for the customlist_value_example value which will be preserved:

Workbook API Is Now Generally Available

The Workbook API is now generally available in this release. The Workbook API supports a wide range of features that let you build SuiteAnalytics datasets and workbooks using SuiteScript. The N/dataset module lets you build datasets, and you can use columns, joins, and conditions to filter your data. The N/workbook module lets you build workbooks using analytics concepts such as data measures, calculated measures, and data dimensions. You can also use the N/workbook module to create pivot tables to analyze your data.

In addition to features that were released previously as beta features, this release includes the following features:

- **Dataset saving** - You can now save your datasets using the new `Dataset.save()` method in the N/dataset module. This method lets you save a dataset with a name and, optionally, a custom ID and description. You can use this method to save a new dataset, but you cannot use it to update an existing dataset (the dataset name and ID must be unique each time you call `Dataset.save()`).
- **Dataset linking** - You can use the new N/datasetLink module to logically join two datasets and use data from both datasets in your pivots. Linking datasets is useful when you cannot use joins in the SuiteAnalytics Workbook UI or the Workbook API to join record types explicitly. Linking datasets does not merge the datasets. Instead, you specify an expression (which usually corresponds to a common column that is shared between the two datasets), and this expression is used to link the datasets. After datasets are linked, you can access all of the data in both datasets to use in workbooks. For more information, see [Dataset Linking in SuiteAnalytics Workbook](#).
- **Pivot execution** - After you define a pivot table for your data, you can now run the pivot and retrieve the results using the new `Workbook.runPivot()` method in the N/workbook module. This method always returns the full results of the pivot, but it can include different data types (such as a record, record key, range, or currency) depending on the pivot. You can run pivots synchronously

or asynchronously in server scripts using the N/task module, or you can run pivots synchronously or using promises in client scripts. You can also run a pivot ad-hoc without a predefined dataset or workbook.

- **Conditional formatting** - You can change the format of cells in pivot tables based on conditions that you specify. You can change the color, font style, or font weight to highlight cells that meet certain conditions. You can also define multiple formatting rules for a cell.

New SecureString.replaceString Method Added to https.SecureString

The [https.SecureString](#) object has a new method: [SecureString.replaceString\(options\)](#). This method is used to replace all occurrences of a pattern string inside an [https.SecureString](#) with a replacement string. The updated string is returned.

This new method is an equivalent of the SuiteScript 1.0 method `nlobjCredentialBuilder.replace(string1, string2)`.

https.SecureString Method Parameters Have Changed

To support more secure functionality of the [https.SecureString](#) object, the parameters in the following methods have been changed or added:

- The [SecureString.appendSecureString\(options\)](#) method now includes the `options.keepEncoding` parameter to keep the appended string in its original encoding.
- The [SecureString.appendString\(options\)](#) method now includes the `options.keepEncoding` parameter to keep the appended string in its original encoding. You should use the [SecureString.appendString\(options\)](#) method only for appending a string (UTF-8) to a [SecureString](#).
- The [SecureString.convertEncoding\(options\)](#) method now includes the `options.fromEncoding` parameter to specify the original encoding to convert from.
- The [SecureString.hash\(options\)](#) method now includes the `options.contentEncoding` and `options.resultEncoding` parameters to specify the encoding to be used for the [SecureString](#) and the resulting hash string.
- The [SecureString.hmac\(options\)](#) method now includes the `options.contentEncoding` and `options.resultEncoding` parameters to specify the encoding to be used for the [SecureString](#) and the resulting HMAC string.

Scripts that use MD5 or SHA1 as the hash algorithm must be updated to use a different hash algorithm, such as SHA256 or SHA512, to ensure these scripts continue to work as expected after the upgrade to 2021.2.

Changes to `nlapiEncrypt`, `CurrentRecord.getValue`, and `Record.getValue` for Custom Password Fields

The use of the SuiteScript 1.0 [nlapiEncrypt\(s, algorithm, key\)](#) function for custom password fields is no longer supported. You should not use the SuiteScript 2.x [CurrentRecord.getValue\(options\)](#) and [Record.getValue\(options\)](#) methods for custom password fields. You can now use [nlapiCheckPasswordField\(type, id, value, field, sublist, line\)](#) for custom password fields in SuiteScript 1.0 and [crypto.checkPasswordField\(options\)](#) for SuiteScript 2.x custom password fields.

Email Send Security Update in 2021.1

A new Vicarious Emails permission that lets users send email on behalf of another user is introduced in August of the 2021.1 release. This new permission allows a role to define an author (sender) that is different from the current user.

This permission is automatically added to existing roles in your account to prevent disruption to current email sent from known users via SuiteScript. However, this permission is not automatically added to roles that can indirectly execute scripts. If these types of roles indirectly execute a script that sends email on behalf of another user, a warning is logged in the script execution log.

When you create a new custom role in your NetSuite account that needs to send email on behalf of another user, you should now include the Vicarious Emails permission.

You need to take action to address these warnings before August 1, 2021. As of August 2021, these exceptions will no longer simply log the warning message but will throw an error. To avoid this issue, you must update script deployments that have this warning in the script execution log to run as roles that have the Vicarious Emails permission. You should not use the Current Role selection in the **Execute As Role** field.

You can identify suspect scripts by reviewing the script execution logs for these Emergency log messages: "Action Required: Email on behalf of other than currently logged in entity was sent by script {the script id}."

Changes to VAT Thresholds in the EU and the Introduction of One Stop Shop (OSS)

As of **July 01, 2021**, the European Union (EU) abolished their distance selling threshold and replaced it with a common threshold of €10,000 for business-to-consumer (B2C) sales throughout the EU. To simplify VAT collection and minimize cross-border compliance costs, the EU extended the current Mini One Stop Shop (MOSS) scheme. The scheme is now called One Stop Shop (OSS) and includes physical, as well as digital, goods and services.

As of 2021.2, NetSuite extends the existing MOSS functionality. If you use Legacy Tax, you can take advantage of the new OSS scheme. With this enhanced feature, you can do the following:

- Set the member state of identification to a particular subsidiary.
- Apply an OSS nexus to transactions where OSS items have been included.
- Enable the OSS feature and enable automatic creation of VAT codes for the 27 EU member states.
- Update VAT determination logic based on the country of consumption of goods and services.

If you were using the MOSS scheme, NetSuite automatically migrates the item records containing the **MOSS Applies** checkbox (regardless of box setting) to the OSS scheme.

Note: The One Stop Shop feature requires that you first install the International Tax SuiteApp (Bundle ID 43003), which provides OSS tax codes and tax types. For more information on installing this SuiteApp, see the help topic [Installing and Setting Up International Tax Reports](#).

Cross-Subsidiary Requisitions

As of NetSuite 2021.2, the Centralized Purchasing and Billing feature enables you to consolidate requisitions entered from any subsidiary into a single centralized purchase order. Regardless of which subsidiary places the requisition or purchase order, Centralized Purchasing and Billing enables you to receive purchased goods and services in any subsidiary and location in your company. When you receive and pay for a purchase order in a different subsidiary, automatic cross-charges balance the ledger and intercompany accounts. Each target subsidiary receives their part of the centralized purchase order in the set target location and generates their own receipt.

To enable cross-subsidiary requisitions, you must enable both the Centralized Purchasing and Billing feature and the Requisitions feature.
