The effect of COVID-19 continues to impact how risk, safety and health managers prevent claims and control exposures. The following session examines trends and observations through each of three significant cycles of reported cases. After exploring the impact of COVID-19 on historical workers' compensation claim trends, the session presents possible risk factors associated with workers' compensation claims. The session ends with risk control best practices that explain the importance of personal protection, good communication, and strong leadership.

Healthcare Non-Patient Related Strain Injuries – Part 1: Critical Program Elements

This is the first of two sessions (see December 9) discussing what may be the most overlooked loss cause in the Healthcare Industry. In healthcare, a significant amount of time is spent on regulatory compliance, safe patient/resident handling, reducing needle exposures, patient/resident falls and pressure ulcer prevention. With the importance of these areas well established, we will pose the question, "How much time is being spent on recognizing and reducing the Non-Patient/Resident Ergonomic and Manual Material Handling risks?" and strategizing ways to promote better risk assessments for employees facing these risks. We will examine the astonishing injury data and key findings in this loss area together before highlighting the "Critical Program Elements" every healthcare organization should consider in their strategy to reduce their Non-Patient/Resident related strains.

This session will provide a general overview of the OSHA Recordkeeping requirements, instructions on completing required forms, electronic filing submissions, and an in-depth analysis of case studies in order to refresh your skills in determining recordability. Further, we will discuss OSHA's COVID-19 guidance issued regarding recordkeeping requirements and guidelines. Whether you're a beginner or very experienced in OSHA Recordkeeping, this multifaceted, interactive session is for you!
