

## REACH regulation - 2006/1907/EC

Valid for paper manufactured by Stora Enso Paper, Nymölla Mill

Stora Enso's obligations under REACH are as a manufacturer and a downstream user of articles and substances and we actively follow any updates to the regulation.

Where REACH demands registration for own manufactured substances we have done or will do the registration, detailed information is found in the Safety Data Sheet for the product. Cellulose pulp is defined as a substance and exempted from registration according to annex IV.

Our products are defined as articles without intended release. For articles our obligation is to inform our customers without undue delay and to notify to the SCIP\* database in case any of our products contain substances included on the Candidate List of SVHCs\*\* in a concentration above 0,1% (w/w).

The SCIP database is established under the Waste Framework Directive (WFD). The SCIP database aims to increase the knowledge of hazardous chemicals and articles and products throughout their whole lifecycle – including at the waste stage.

As a downstream user we have included REACH demands in our purchasing agreements to secure information exchange in the supply chain. Chemicals that we buy shall be registered for our uses unless exemptions apply, the suppliers shall continuously follow the development of the Candidate List of SVHC, the substances for authorization as well as any restrictions applicable to our use. The chemical suppliers are obliged to inform Stora Enso in case any chemical substance is/will be listed as SVHC.

At the date of signing of this document our products do not contain substances included on the Candidate list in a concentration above 0,1% (w/w). Our products do not contain substances that require authorization, or substances included in Annex XVII, Restrictions, where the restriction is applicable on our use.

As REACH requires, we'll inform our customers if any of our products contain substances included on the Candidate list in a concentration above 0,1% (w/w), substances that require authorization, or any substances included in Annex XVII, Restrictions, where the restriction is applicable on our use.
