

 - Requires skill
 - Person trained in that skill

WHEN DO I NEED TO GIVE THE DONOR AN ACKNOWLEDGEMENT?

- DONOR ONLY NEEDS SOMETHING FROM THE CHARITY IF IT'S A GOOD
- AND THE VALUE IS > \$250
- YOU AREN'T REQUIRED TO GIVE IT TO THEM
- BUT ITS GOOD TO DO IT ANYWAY
- YOU SHOULD DESCRIBE THE GIFT BUT
- DO <u>NOT</u> VALUE IT IN THE ACKNOWLEDGEMENT!

5 THINGS A DONOR ACKNOWLEDGEMENT SHOULD CONTAIN

- CHARITY NAME AND EIN #
- CHARITIES TAX EXEMPT STATUS
- DATE OF CONTRIBUTION
- AMOUNT OF CONTRIBUTION (or description)
- A STATEMENT STATING
 - NO GOODS/SERVICES WERE EXCHANGED FOR THIS CONTRIBUTION
