#### Terms and conditions

Information on how to enter and the prizes form part of these Terms and Conditions.
Participation in this promotion is deemed acceptance of these Terms and Conditions.

## Who can enter?

- 3. Entry is only open to Australian residents aged 18 years or over.
- 4. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter. 16.
