Issue of Share Purchase Plan Shares

Family Zone Cyber Safety Ltd (“Family Zone” or the “Company”) (ASX: FZO), *supporting and protecting every child's digital journey*, is pleased to confirm the issue of 4,679,466 shares today following the successful completion of the Share Purchase Plan (**SPP**).

The SPP was announced on 23 October 2020 as part of a two stage capital raising, comprising a \$20 million placement to institutional, professional and sophisticated investors (**Placement**) followed by a SPP targeting \$2 million, providing eligible shareholders the opportunity to participate in the capital raising at the same issue price as the Placement.

The Company is very pleased with the support from shareholders which followed similar strong support from institutional and professional investors in the preceding Placement. The funds raised from the SPP and Placement will principally be used to fund the acceleration of the Company's growth strategy into existing markets as well as expansion into new markets.
