Family Zone Cyber Safety Ltd (ASX: FZO, **Family Zone** or the **Company**) advises, further to its capital raising announcement on 23 October 2020, that 45,454,545 Shares have been issued at \$0.44 per share raising \$20 million under its Placement to sophisticated, institutional and professional investors.

The Placement shares have been issued under the Company's Listing Rule 7.1 and 7.1A capacity with 12,282,789 shares issued under its Listing Rule 7.1 capacity and 33,171,756 shares issued under the Listing Rule 7.1A capacity.
