Building Engineer	Performs complex preventive maintenance and corrective repair of buildings, industrial systems, vehicles, equipment and grounds.	CDCP CDCS	CDFOS
Facilities Manager	Manages and maintains the data center facilities to ensure continuity and availability of data center services in an effective and efficient manner.	CDCP CDCS CDFOM CDESS	CDRP CTDC CNCDP
Facilities Engineer	Operates, monitors and supports physical facilities conditions. Some of these duties will include heating and cooling of air and water, power supply, generators, UPS systems, electrical distribution and control and monitoring systems.	CDCP CDFOS CDESS	CDCS CNCDP
