




### **BECOMING RENEWABLE**

### WALL OF SHAME – AUTHORIZATION IS COMPLEX

- Authorization to see and do things in BTP is split between:
  - Authorization for configuring BTP platform services (UAA)
  - Authorization **for**, *and* **within** the different **services/apps** running ON the BTP (**XSUAA**)
- Difficulties are in the details:
  - Having one app 'talk' to the other with right authorization
  - Not having the right **authorization** for the platform makes certain menus **invisible** to you.
  - Making connections between IDP and the BTP relies on some 'free text' fields. Check for typos!
  - Every **service / app** comes with its **own roles**. Make sure to work with a '**Cloud Admin**' to set these roles right!

The platform doesn't tell you when you don't have authorization. Things will simply not be visible

### WALL OF SHAME – THE DIFFICULTIES: GETTING A GRIP ON COSTS

#### - For 'pay-as-you-go' each service has their own model.

Service	License model
SAP Integration Suite	<ul> <li>Per 10 messages, or</li> <li>Fixed price per month</li> </ul>
Workflow Management	<ul> <li>Per user ( user price depends on total users )</li> </ul>
SAP BTP Cloud Founry Runtime	- Per GB of memory used
SAP Internet-of-Things	<ul> <li>Per 'capacity unit' used ( minimum 425 )</li> </ul>
Business Partner service	- Per 1000 API calls + storage in GB



#### WALL OF SHAME – SERVICE UPGRADES

- BTP services are frequently updated (great!), but it's not always clear when and how. Here are two examples:
  - Some years back, some **data** in our **IoT instance** suddenly **disappeared.** After a lot of searching, we found it was due to an **error** in de **upgrade process**. Luckily, the data could be **recovered.**
  - The upgrade to 'feature set B' for Cloud Foundry subaccounts resulted of blocking our developers from deploying apps. It turns out that authorization had been made stricter. Make sure to have a few 'Cloud Admins' ready to step in!
- Information about service maintenance is not centralized. Luckily, SAP provides a subscription service to be notified of upgrades of certain BTP services :

#### WALL OF SHAME – SUBACCOUNT SETUP

- BTP uses **Global Accounts** and **Subaccounts**.
  - BTP 'Global Accounts' are mainly administrative units determining usage quota for activated services
  - Subaccounts represent real pieces of hyperscaler server space around the world
- For the setup of these subaccounts, a lot of choices need to be made
  - Running on a hyperscaler ( **Cloud Foundry** ) or on SAP's own cloud ( **NEO** )
    - For Cloud Foundry, choosing a hyperscaler (e.g. Azure, AWS, GCP, Alibaba)
    - For the hyper scaler, determine which server location (**Europa, America, Asia**, etc)
- How many **subaccounts**, and how to use them together, e.g.
  - Shared subaccount for running a 'heavy' service like HANA Cloud ?
  - A Subaccount each for **Development, Test, Acceptance** and **Production**?
- Migrating **NEO** subaccounts to **Cloud Foundry**

  - SAP Analytics Cloud / Sales Cloud / etc
  - SAP SaaS (Ariba, Successfactors)
  - Third party systems
  - Intelligent technologies (IoT / Machine Learning)


