2022 Rules and Regulations

- 1. This tournament will be a USBC certified event.
- 2. The youth participant must hold a current USBC Youth membership and the adult participant must have a current USBC adult membership.
- 3. Multiple participation is permitted provided they are not bowling on the same squad. In order to place more than once in the prize list for positions standings, at least one player in the lineup must be different Adult/Child.
- 4. Parent/Youth and Parent/Teen must be parents, step-parents, grand parents, step-grand parents, great grand parents, step great grandparents or court appointed legal guardians bowling with a son or daughter: All other classifications will bowl in the Adult divisions. Parent-Adult/Youth ages 12 years or younger as of April 23, 2022, Parent-Adult/Teen 13 years of age or older, but who have not reached their 18th birthday as of August 1, 2021. As used herein, stepparents shall include domestic partners (in recognized domestic partnerships) of the child's parent.
- 5. Adult bowlers and youth bowlers shall use their highest average from the previous season (2020-2021). All averages must have a minimum of twenty-one (21) games. If you do not have an average from 2020-2221 season then you may use your highest 2019-2020 season average or your current average of 21 games or more as of April 1, 2022 (whichever is highest). **Proof of average must be presented at check in.**
- 6. Handicap will be 100% of 440, based on a team basis. All entering averages must be USBC CERTIFIED or the bowler must bowl scratch (220).
- 7. The tournament director has the right to re-rate a bowler at anytime. The adjustment must be accomplished before the entrant bowls and if the adjusted average is not accepted by the bowler, the entry fee shall be refunded (USBC Rule 319c). All entrants who have ever been re-rated, refused a re-rate or been disqualified in a tournament must report this at every level of the tournament for a possible re-rate.
- 8. Any bowler that fails to report their highest average will result in automatic disqualification from the tournament in accordance with USBC rules.
- 9. The USBC Rule #319a/3 (ten pin rule) has been waived for this tournament.
- 10. The BCAF Tournament Director has the right to accept or reject any entry.

GENERAL PLAYING RULES

- 1. This tournament will only be conducted in a BPAA/BCAF member establishment.
- 2. Prize money for any positions tied with handicap shall be split evenly. Prize money will be awarded in the form of Smart Scholarships to the youth participant. Adult participants will not be awarded any prize money.
- 3. Participation in any Tournament sponsored, conducted or held by or on behalf of BPAA is open, upon the same terms and conditions, to all bowlers who do, or have done, any league tournament, advertised exhibition or any other type bowling (a) in a BPAA member establishment (b) in a non BPAA establishment, (c) whether such bowler is or is not a member of any bowler's membership organization. Any owner or employee of any bowling establishment may participate if otherwise eligible. Rules and regulations conducted by the Bowling Proprietors' Association of America, Inc.
- 4. Alcohol may be consumed by adults over 21, but <u>NOT</u> DOWN BY THE BOWLING AREA or NEAR THE LANES. Tournament staff reserves the right to determine what defines near the lanes.
- 5. All matters not covered by these Rules and Regulations will be determined by the on-site tournament director. All decisions will be final unless an appeal is made in accordance with USBC Rule 329.
- 6. Please arrive 30-45 minutes before your scheduled bowling time. If you arrive 15 minutes or less from your start time we cannot guarantee you will bowl.
- 7. Lanes are randomly assigned and cannot be changed.
- 8. No refunds will be given after March 31st, 2022.
