

Fuel to Trip Memo

Our goal as a business partner is to ensure your business is set up for success. With the introduction of fuel to trip processing, we want to ensure you have all the necessary information to successfully navigate this transition with us. Please see the Fuel to Trip Process instructions below as well as an example to fully illustrate this new process.

Fuel to Trip Process Instructions

- 1. Call 24/7 to be dispatched
 - At this time, your fuel card will be activated
 - You will be allotted 225 gallons in a 24-hour period as a solo IC
 - You will be allotted 275 gallons in a 24-hour period as a team
- 2. At the pump, enter your driver number and then your trip number
 - 1. Your trip number is identified on your stop list and manifest
 - 2. It is the 7 numbers before the dash

- This enables the fuel purchase to be attributed to the trip
 - Once entered, you will be able to fuel up to your allotted amount
 - Fueling will be valid only if you have been dispatched
 - If you have not been dispatched, you will **NOT** be able to fuel
- 3. After completing your trip, Transflo your paperwork associated with the trip
 - The cost of fuel will not be taken out of settlement until your trip has been processed through Transflo



 If paperwork has not been processed through transflo, fuel will automatically be deducted on the 7th day after initial dispatch, and it will not match your trip

Settlement View and Execution

- Your fuel purchases will now be linked to your trip numbers in settlement
- Your fuel will be deducted from settlement when you transflo your documents after load completion
- If you do not transflo your documents
 - Fuel will be deducted 7 days after initial DSP
 - Revenue from the specific trip will not be settled if transflo is not done timely
- Your Settlement will show your fuel purchases by trip:

Example of New Fuel to Trip Process For Missing Trips:

- Settlement is run every Wednesday
- Any fuel prior to the previous Wednesday will be deducted whether or not documentation was submitted through Transflo
- It is critical that all documentation is submitted when loads are complete. This will ensure proper settlement timing and accurate matching of your fuel purchases to the proper trip.
- Rule of thumb: Transflo your trip documents as soon as the trip is complete



Fuel to Trip FAQ

When will fuel to trip be active?

June 1, 2020 at 1500 CST

Will my fuel card still have a limit with fuel to trip?

Yes. It will remain 225 gallons for a solo IC in a 24-hour period. For teams, the limit is 275 gallons in a 24-hour period.

If I'm not dispatched on a load, will I still be able to fuel?

No. You must be dispatched to fuel.

Do I need to call 24/7 to be dispatched?

Yes. You must call to be dispatched on a load before you will be able to fuel. You may also dispatch yourself from the Haul NOW app.

With fuel to trip, when will deductions be taken out?

If documents are submitted in a timely manner, fuel will be deducted when the trip settles. If documents are not turned in, fuel will automatically be deducted after 7 days of sitting on hold.

What information will I need to enter at the pump with fuel to trip?

Your tractor number and trip number, which can be found on your manifest. Your trip number will be the first 7 digits before the dash.

When do I need to Transflo my paperwork?

As soon as possible after the trip. However, it will be taken out of settlement after 7 days.

Can I still purchase fuel through another means besides my fuel card?

Yes. If you purchase fuel with cash or with an outside credit card, please make sure to send to cashfuelreceipts@rrts.com in order to have accurate fuel tax reporting completed.
