Visiting our Website

When you visit our website, we collect the following information:

- IP address
- Browser type and language
- Which pages have been visited by you

We collect this information to see how our website is used and where our users are located. This information allows us to optimize our website for the best user experience.

Contact Request

Via our website you can request to be contacted by us. For that, we collect the following information with your consent:

- First name
- Last name
- E-mail address
- Company name
- Your request / idea / comment / message

We use these data for the following purposes:

- To be able to contact you as requested
- To keep track of with whom there has already been contact, and what the contact question was about

In this case we store your data in our Customer Relations Management (CRM) system.

Customers and Contacts

We store customer and contact data in our CRM system. This is a database in which we can keep track of all customer data and contacts with customers. For this purpose, we collect the following data with your permission:

- First name
- Last name
- Business addresses
- Business phone number
- E-mail address
- Company name
- Your request / idea / comment / message

We use these data for the following purposes:

- To be able to contact you, as requested
- To keep track of with whom there has already been contact, and what the contact question was about
- To retain customer data for necessary transactions

These data will not be retained longer than necessary, or until you indicate that you wish to withdraw your permission for that. You can withdraw your permission for the processing of your data by sending an e-mail to: info@entrnce.com.

Use of the ENTRNCE platform

If you use our ENTRNCE platform as a customer, we process the following data with your permission:

- Telephone number
- E-mail address
- Company name
- KVK number
- VAT number
- IBAN
- Electricity buy/sell orders
- Electricity connection masterdata
- Electricity connection consumption data
- User actions on the platform

We use these data for the following purposes:

- To be able to contact you in case of any problems.
- For settlement and invoicing.
- To see how the platform is used. This information allows us to optimize our platform for the best user experience.

Data Processors

We may commission a third party to perform a particular service for us. If this third party has access to or uses your personal data, then this third party is a processor. We have taken the necessary contractual and organizational measures to ensure that our processors only process personal data for the stated purposes.

Security

website (we use https) and by handling the material and features we offer through the website with all due care.
