If loan is protected by Member's Choice™ borrower security debt cancellation protection, these charges will continue to accrue. An approved Skip-A-Payment request will extend the term of the loan. Interest will continue to accrue during the month skipped. Loan not to exceed two skips per year or five per lifetime of the loan. Not all loans are eligible for a skip.

**Please note: If your monthly payment is scheduled to be transferred to us by ACH from any outside financial institution, your request must be received 3 business days prior to the transfer to ensure it can be stopped, once skip request is approved.**
