# Your data protection rights

As a data subject you have the following rights regarding your personal data. The rights available to you will depend on our reason for processing your personal data:

- 1. Right to be Informed
  - a. You can ask for information on how your information is collected and used.
- 2. Right of Access
  - a. You have the right to ask us for copies of your personal information. This right always applies. There are some exemptions, which means you may not always receive all the information we process
- 3. Right to Rectification

- a. You have the right to ask us to rectify information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.
- 4. Right to Erasure
  - a. You have the right to ask us to erase your personal information in certain circumstances.
- 5. Right to Restriction of Processing
  - a. You have the right to ask us to restrict the processing of your information in certain circumstances.
- 6. Right to Object to Processing
  - a. You have the right to object to processing if we are able to process your information because the process forms part of our public tasks or is in our legitimate interests.
- 7. Right to Data Portability
  - a. This only applies to information you have given us. You have the right to ask that we transfer the information you gave us from one organisation to another or give it to you. The right only applies if we are processing information based on your consent or under, or in talks about entering into a contract and the processing is automated.
- 8. Rights in relation to automated decision making and profiling
  - a. You have the right to not be subject to a decision based solely on automated processing. Processing is "automated" where it is carried out without human intervention and where it produces legal effects or significantly affects you.

### **Sharing your Personal Data**

We will not share your information with any third parties for the purposes of direct marketing.

The agency may also enforce its Terms and Conditions, including investigating potential violations of its Terms and Conditions to detect, prevent or mitigate fraud or security or technical issues; or to protect against imminent harm to the rights, property or safety of Kingdom Services Group Ltd its clients and/or the wider community.

If Kingdom Services Group Ltd is dissatisfied with the quality, further information may be sought before personal data can be released.

## Complaints
