- The new law prohibits handing “any money or gifts, including, but not limited to, food and drink” to anyone standing in line to vote. The prohibition extends 150 feet from a polling place and 25 feet from any person standing in line. Campaign materials, food, and water can be handed to voters beyond those distances.
- The new law requires each Georgia county to have a minimum of one drop box for the return of absentee ballots and sets limits on the number of drop boxes and the hours voters are allowed to drop off their ballots in the boxes. Drop boxes were previously not required under Georgia law and were provided on a temporary basis during the 2020 election due to the pandemic.
- The law requires the state of Georgia to monitor polling locations to see if any have lines longer than an hour, or still have voters waiting in line for more than an hour after polls were supposed to close. In such instances, the state is required to either form new precinct locations to ease the strain or increase the existing polling locations’ capacity to handle large numbers of voters. This applies specifically to populous precincts, mostly in urban areas.
- The new Georgia election law expands weekend early voting to require two Saturdays of early voting and the option of offering two Sundays, as well. Previously, one day of weekend voting was required in Georgia.
- The new Georgia election law says that election officials and local authorities may make self-service water stations available to voters waiting in line.
- The new Georgia election law says that counties can only send absentee ballot request forms to voters who ask for them (as opposed to automatically sending them to all voters).
