

CONTEST RULES AND REGULATIONS

2021 Australian & New Zealand Addiction Conference In-Person Registration Giveaway

- 1. Contest opens at 08.00am AEST 20 May 2021 and closes at 11.59pm AEST 30 May 2021.
- 2. To enter and be eligible to win, entrants must be a legal resident of Australia or New Zealand and be eighteen years of age or older. Employees and their parents, siblings and children, and persons domiciled with an employee of Australian & New Zealand Mental Health Association Inc., and any other organisation, media, or businesses who assist or aid in the contest are ineligible to enter.
