PRESENTER/KEYNOTE/POSTER PRESENTATION TERMS & CONDITIONS

1. INTRODUCTION

- 1.1 The conference is organised and managed by Conference & Education Management t/a AST Management; a company registered in Australia (ABN 11 134 242 292).
- 1.2 References to "us" means AST Management and references to "we" and "our" shall be construed accordingly. Reference to "you" means the person/s/entity speaking or presenting at the conference who is completing a booking request and references to "your" shall be construed accordingly.
- 1.3 All applications to speak/present at the conference are made subject to these Terms & Conditions (which shall apply to the exclusion of any terms imposed by you). The term 'Presenter' is used throughout this Agreement and includes those people who are presenting on stage during the conference in any capacity as well as those who are displaying poster presentations, table top presentations, fishbowl, word café, Pecha Kucha or any other format of delivering a presentation at the Conference.
- 1.4 You acknowledge and accept that we have the right to publicly announce our business relationship with you which shall include but not be limited to announcements on social media. Such announcements shall not be disparaging or otherwise adverse to your business.
- 1.5 You must be at least 18 years of age to register and attend the conference, unless otherwise agreed with the conference organiser. Attendees may be asked to present an official identity card stating their age.
- 1.6 All conference registrations include a free membership to the Australian & New Zealand Mental Health Association. 2. BOOKINGS

- 2.1 All application/s to register as a speaker for the conference are subject to availability and you making full payment.
- 2.2 Confirmation (or rejection) of your booking will be sent to you by email within two (2) working days of our receipt of your booking request.
- 2.3 Presenter passes issued for use at the conference are valid for named attendee only and, subject to clause 4.2 below, cannot be transferred. You may be asked for photographic ID during the conference. If you are unable to provide identification which matches your attendee pass you may be asked to leave the conference.

3. PRICES AND PAYMENT

- 3.1 Our prices for presenters attending the conference are set out on the relevant registration booking form obtained from your abstract acceptance email. Prices may be subject to change from time to time.
- 3.2 Presenters accepted in the conference program are required to register and pay their own attendance by Friday 5 August 2022. If the conference registration and payment has not been received by this date, the conference reserves the right to allocate your presentation slot to another speaker on the waitlist.
- 3.3 If your booking has been confirmed an invoice will be sent to you within two (2) working days setting out the relevant payment instructions and terms. Payment is due within seven (7) days on receipt of this invoice or 10 business days prior to the conference (or by the Early Bird close date whichever comes first).
- 3.4 Early Bird Registration Attendees must have registered and paid by Friday 16 September 2022 to be eligible for the early bird registration. Registration payments not received by close of business Friday 16 September 2022 will revert to the standard rate.
- 3.5 Please be advised that credit card fees apply for payments made via credit card of 1.75% + \$0.30 per transaction for all card types.
- 3.6 Credit Card payments are made directly through Stripe to ensure your personal details are kept safe. None of your payment details are stored by AST Management.
- 3.7 If for any reason we have not received payment in full by the date of the conference you (or the attending delegate) may be refused entry to the conference. We reserve the right to cancel your booking at any time if payment is not made.
- 3.8 You acknowledge and accept that if payment is not made in accordance with this Clause 3, interest on the overdue balances (including any period after the date of any judgment or decree against the Customer), and a late payment fee of 2% will be applied.

4. CHANGES TO THE CONFERENCE AND CANCELLATIONS

- 4.1 It may be necessary for reasons beyond our reasonable control to alter the advertised content, timing and/or location of the conference or the advertised speakers. We reserve the right to do this at any time. Where we alter the time and/or location of the conference, we will provide you with notice of the same and will offer you the choice of either a credit for a future event of your choice (up to the value of sums paid by you in respect of the conference) or the opportunity to attend the conference as varied.
- 4.2 a If you are unable to attend the conference, we welcome a substitute presenter attending in your place at no extra cost provided that we have at least 2 days prior notice of the name of your proposed substitute and have received payment in full. Please notify us of any substitutions by email at rural@anzmh.asn.au. NB. In the event you are unable to present at the Conference, you are not responsible for finding a substitute presenter and have no right to make arrangements to this effect. You may be asked by AST Management to help assist in finding a suitable replacement, but this is at the discretion of AST Management.

- 4.2. b If you are unable to attend the conference due to government restrictions, but the event is still proceeding, you need to notify the secretariat via email seven (7) days prior to the event and you will have the following options (providing proof of location is supplied) If your selection has not been received seven (7) days prior to the event in writing, you will forego the below options and your registration will remain unchanged:
 - i) Convert your in-person registration to a virtual registration for you and 3 colleagues
 - ii) Convert your in-person registration to a virtual GOLD PASS, allowing online access to seven mental health conferences.
 - iii) Transfer to a virtual registration and the difference in price will be refunded
 - iv) Transfer in-person registration to 2023 conference
 - v) Full refund of paid registration (less any related credit card transaction fees)
- 4.2.c As a presenter, if government restrictions prevent in-person attendance, please contact the secretariat, who will discuss the virtual presentation options available with you. Note that this could involve, a pre-recorded presentation to be included in the Conference On Demand Library, accessible to all virtual and in-person attendees within 72 hours of the conference date.
- 4.3 Conference registrations are not refundable, except as stipulated in s4.2.b. Non-payment does not constitute cancellation.
- 4.4. Cancellations of accommodation booked through the conference website ninety (90) days or more prior to the check-in date will receive a full refund of the relevant accommodation fees; cancellation within ninety (90) to sixty (60) days prior to check in date will receive a 50% refund; cancellations within sixty (60) days of the check-in date will not be refunded, except where government restrictions prevent your attendance, and the host hotel approves of the refund.
- 4.5 The organisers shall not be liable for any loss caused by the cancellation of the Conference where such cancellation is due to Force Majeure. The term "Force Majeure" means any circumstance beyond the reasonable control of the organisers including but not limited to War, hostilities (whether war be declared or not), terrorism, aircraft hijacking, military operation, riot, civil war, rebellion, civil commotion or unrest, Acts or Regulations of government, refusal to grant visas, explosions, natural disasters, transport delays, transport difficulties and the insolvency of airline carriers.

- 6.2 Subject to Clause 6.4, we shall not be liable to you for (i) any loss of profit, loss of or damage to data, loss of anticipated savings or interest, loss of or damage to reputation or goodwill or; (ii) any indirect, special or consequential damages, loss, costs, claims or expenses of any kind.
- 6.3 You agree to indemnify us, our staff and our affiliates and to hold us harmless to the fullest extent permitted by law, against all loss, costs, claims or expenses of any kind arising from any act or omission by you (including your delegates) during or otherwise in relation to a conference.
- 6.4 Nothing in this these Terms and Conditions shall limit or exclude either party's liability for:
- 6.4.1 death or personal injury caused by that party's negligence, or the negligence of that party's employees, agents or subcontractors.
- 6.4.2 fraud or fraudulent misrepresentation; or
- 6.4.3 any other liability which cannot be limited or excluded by applicable law.

7. ANTI-BRIBERY

7.1 You warrant that you shall:

- 7.1.1 comply with all applicable laws, statutes and regulations relating to anti-bribery and anti-corruption.

- 7.2 Breach of this clause 7 shall be deemed a material breach of these Terms and Conditions.

8. GENERAL

- 8.1 These Terms and Conditions (together with any documents referred to herein or required to be entered into pursuant to these Terms and Conditions) contain the entire agreement and understanding between us and supersede all prior agreements, understandings or arrangements (both oral and written) relating to the subject matter of these Terms and Conditions and any such document.
- 8.2 You acknowledge that in registering as a presenter, you have not relied on, and shall have no remedy in respect of, any statement, representation, warranty, understanding, promise or assurance (whether negligently or innocently made) of any person other than as expressly set out in these Terms and Conditions.
- 8.3 These Terms and Conditions shall not create, nor shall they be construed as creating, any partnership or agency relationship between us.
- 8.4 You accept that communication with us may be electronic. We may contact you by e-mail or provide you with information by posting notices on our website. You agree to this electronic means of communication and you acknowledge that all such communications that we provide to you electronically comply with any legal or contractual requirement that such communication be made in writing.
- 8.5 Save as set out in Clause 4.2 you are not permitted to re-sell, transfer, assign or otherwise dispose of any of your rights or obligations arising under these Terms and Conditions.
- 8.7 These Terms and Conditions and the rights and obligations of both parties shall be governed by, and construed in accordance with, the laws of Australia and both parties irrevocably agree to submit to the exclusive jurisdiction of Australia in respect of any dispute which arises hereunder.

9. ATTENDANCE

9.1 Your attendance at the Conference is, at all times, at the sole discretion of AST Management. AST Management reserves the right to refuse entry to you to the Conference, or to request that you leave the Conference, without notice for any reason whatsoever. If this occurs, then a refund of the registration fee will be facilitated in some circumstances (at AST Management's sole discretion).
