

Gaggle Insight: 2020–21 School Year

During the 2020–21 school year, Gaggle's data from our North Carolina district partners revealed:



2019-2020 2020-2021

165% increase in student safety incidents



81% increase in Suicide & Self-Harm (from 120 to 218 incidents per 10,000 students)



58% increase in Violence Toward Others (from 97 to 153 incidents per 10,000 students)



118% increase in Nudity & Sexual Content (from 47 to 102 incidents per 10,000 students)



127% increase in Drugs & Alcohol (from 22 to 50 incidents per 10,000 students)



31% increase in Harassment (from 28 to 37 incidents per 10,000 students)
