The first step to getting patients on the right path to recovery is an accurate diagnosis. One of the key solutions they use for every new patient is the nView Mini International Neuropsychiatric Interview, also known as the M.I.N.I.

According to Dr. Lado, the M.I.N.I. is the gold standard in the industry for assessing complex mental health disorders. "It has become a gold standard in my practice because it helps achieve a greater degree of patient disclosure and has a high level of specificity and sensitivity in evaluating psychiatric disorders," Dr. Lado said.

### A Holistic Approach

There are many advantages that the Lado Healing Institute and its staff are realizing when using the M.I.N.I. during initial patient assessments. Because it is comprehensive in nature and can assess for virtually all major mental health disorders (24 in children and 17 in adults), the Lado Healing Institute can look more holistically at each patient. Typically, patients are given access to the M.I.N.I. in advance of the visit – either via email to complete in the privacy of their own homes or in the waiting room when they enter the office.

By having the assessment results before the visit, the clinician does not have to spend the bulk of the initial visit capturing patient insights and documenting notes. Much of the necessary information is captured electronically in the system for reference. As a result, the clinical team is able to see more patients and make better use of the face-to-face time they have with patients – whether it is in-person or via a telepsychiatry visit.

### Improved Patient Self-Disclosure

Another key to accurately diagnosing a patient with a mental health or substance abuse disorder is access to complete

self-reported symptoms and patient history. However, over his many years of practice, Dr. Lado has learned that some patients can be reluctant to disclose certain information because they are embarrassed, concerned about confidentiality, or simply because they are unaware that specific experiences are related.

“Unlike in many physical health issues where an X-ray or lab test can be used to accurately assess a health issue, we must rely on accurate and complete information from our patients to ensure we can properly diagnose and establish the right treatment plan as quickly as possible,” said Dr. Lado. “When we administer the electronic M.I.N.I., we often find that patients are more willing to share information on a computer than directly with a clinical professional they are just meeting for the first time. It helps us determine if a patient is being genuine and consistent with the information they are sharing, which ultimately helps us get to a more accurate diagnosis faster.”

### Highly Effective Clinical Trial Screens

In addition to his clinical practice, Dr. Lado is often involved in clinical trials for various medications and approaches to mental healthcare. When qualifying candidates for clinical studies, he depends on the accuracy of the nView digital Screens to identify study candidates. Taking less than 3 minutes on average to complete, the Screens can be used to identify symptoms that may require further evaluation via the M.I.N.I. to ensure individuals are the right fit for a particular study.

### Progress Monitoring and Outcomes Reporting
