A call to action—Reach out to your legislators regarding Medicaid payments

As the State's 2017 legislative session nears the finish line it is critical that employees across Care New England advocate for our hospitals by reaching out to their legislators and ask them to protect hospital employees and patients by enacting a state budget that increases hospital Medicaid payments and funding to care for our most vulnerable citizens. This effort is being conducted in conjunction with other members of the Hospital Association of Rhode Island (HARI).

The State has not increased hospital Medicaid rates since 2013, and in some years payments have been reduced. Meanwhile, the cost of providing care continues to increase and hospitals face uncertainty at the federal level. The State has set limits on payments from commercial insurers.

The current budget proposals cut funding required to offset the cost of providing free care to Rhode Islanders without the ability to pay. Years of continued reductions have left our hospitals in a critical condition rather than allowing us to invest in both our workforce and patient care.

Please tell the General Assembly to invest in hospitals, employees, and patients. There are three easy steps to participate in the campaign:

- 1. Visit the <u>HARI Action Center</u>.
- Enter your information (the system will then identify your elected officials based on your home and business addresses).
- 3. Click "Send Message" to send a pre-written email to elected officials.

Availability of PTO accruals on iCare

Several months ago, CNE implemented an upgrade to our Unicorn/Icon payroll system. As a result of this upgrade, some of the entitlement (e.g. vacation, PTO, sick, etc.) functionality stopped working. Specifically, no longer being able to display entitlement balances on iCare (also known as the "PTO on iCare" issue). This also affected the functionality related to the calculation of maximum accruals allowed. Since this has occurred, a team has been working diligently with our vender and in the department to fix these two issues.

Effective Friday, June 9, we are pleased to announce your entitlement balances will be available on iCare. However, maximum accrual functionality is still not working.

The remaining issue of maximum accrual functionality means the system continues to accrue entitlement benefits (e.g., vacation, PTO, sick, etc.), even when your defined maximum has been met. For those individuals who are affected, once this functionality is working again, the balance will be corrected to reflect the maximum allowed. Allowable maximum hours are posted on carenet in the Human Resources portal in the Benefits section.

Thank you for your patience as we continue working toward a solution.

Care New England launches new Spine Care Program

Spine problems (back and neck pain) are the leading cause of disability in the United States and are among the principle drivers of the current opioid crisis. In response, CNE has launched an innovative new Spine Care Program that brings greater efficiency, effectiveness and cost-effectiveness to spine care. The focus, consistent with the CNE mission and values, is to help patients with spine problems become our partners in the care of their problems, and help them become healthier and more productive in their lives.

The program incorporates an integrated spine care pathway in which primary spine practitioners (PSPs, who are specially trained chiropractors), physical therapists, spine surgeons, behavioral health specialists, acupuncturists, injectionists and others come together in a team environment to ensure that each patient receives the right care at the right time, with emphasis on teaching patients how to care for themselves.

The medical director of the program is Donald R. Murphy, DC, FRCC, who has helped successfully implement this integrated pathway in several other environments. The pathway uses a "stepped care" approach, in which the most effective, least invasive and least costly services are applied first (by primary spine practitioners in coordination with physical therapists), with a focus on teaching patients self-care methods. In the relatively uncommon cases in which the problem persists, higher intensity services are applied, with the patient carefully followed by the PSP to ensure they are experiencing maximum benefit.

Kent Residency Program recognized at Northeast Osteopathic Medical Education Network event

The Kent Hospital Residency Program participated in the 16th Annual Research and Scholarship Forum of the Northeast Osteopathic Medical Education Network (NEOMEN). The event was held on May 18 at the University Of New England College Of Osteopathic Medicine in Biddeford, Maine. Residents and medical students from throughout New England were selected to present case reports and original research projects. This year nearly 150 were presented.


awarded second place for her report, "Kawasaki Disease: A 'Can't-Miss' Diagnosis." In the Resident Research category 16 projects were presented. Kent Hospital was strongly represented.

Dr. Edward Medeiros; an internal medicine PGY-II, was awarded third place for his research "Utilization of Prediction Models for Pulmonary Embolism in a Community Emergency Department." Dr. Regina Sutskever; a PGY-III in the Internal Medicine program, received second place for her research, "Overuse of Telemetry Monitoring in Patients with Respiratory Disorders." First place was awarded to Dr. Bryn DeKosky, a PGY-II in the Emergency Medicine Program for her project titled, "Efficacy of Complex Care Plans in Regards to High Utilizers in the Emergency Department."

In the student case report category there were 37 poster presentations. UNECOM MS-III Andrew Ea has spent his third year at Kent Hospital and was mentored in his presentation by Joseph Brady, MD, Kent Hospital surgeon. He was awarded first place for his report, "Meckel's Diverticulum in a 40 Year-old Male."
