Making connections

Last week's CNE Behavioral Health Services Open House, hosted at Butler's Ray Hall, drew more than 50 people from the community who are key referral sources. Additionally, with more than 30 CNE behavioral health care providers participating, the open house offered an opportunity to build stronger connections within CNE's behavioral health network across the system. Along with the large team of people from Butler, there were representatives from Integra,

The Providence Center, Anchor Recovery, Continuum Behavioral Health and Women & Infants. Butler's Call Center services gained more visibility, with a great deal of positive feedback on creating this single point of access to make it easier for people to find the right services.



Community Benefit reporting

As part of the justification for Care New England's non-profit status, CNE is required to report to the IRS (Form 990) the community benefit work the system sponsors or supports. It is the time of year when we are requesting the submission of any qualifying department programs. Please see the guidelines below for what counts and what does NOT count as a community benefit.

For a program to COUNT as a community benefit activity, it must:

- · Address a documented community need.
- Have at least one of these community benefit objectives:
 - Improve access to health care services.
 - Enhance health to the community.
 - Advance medical or health care knowledge.

A program DOES NOT COUNT as a community benefit if:

- The program is primarily for marketing purposes.
- The program or donation is unrelated to health or the hospital's mission.
- An objective "prudent layperson" would question whether the program truly benefits the community.
- The program benefits the organization more than the community.

- The program represents a community benefit provided by another entity or individual.
- Access to the program is restricted to individuals affiliated with the hospital.
- The activity represents a normal "cost of doing business" or is associated with the current standard of Care New England.

Women & Infants completes Joint Commission survey

Last week, Women & Infants underwent a rigorous four-day survey by The Joint Commission (TJC) and the results were excellent! Women & Infants is the first CNE hospital to be surveyed using the new scoring methodology, implemented in January 2017. The new scoring methodology—the Survey Analysis for Evaluating Risk (SAFER) matrix—is intended to better identify and communicate risk levels associated with deficiencies cited during surveys.

The **SAFER** matrix replaces the TJC's former scoring methodology, thereby, eliminating Category A and Category C findings, as well as direct and indirect impact Elements of Performance.

All Requirements for Improvement (RFIs) are plotted on the **SAFER** matrix according to the likelihood the issue could cause harm to patient(s), staff, and/or visitor(s), and the scope at which the RFI is observed. Combined, these characteristics identify a risk level for each RFI, which in turn will determine the level of required post-survey follow up.

The survey results included a total of 34 findings, none of which rose to the level of high or immediate threat to life. These are excellent results, as most surveys conducted since the implementation of the new scoring process have ranged from 42 to 100 findings.

While the surveyors did find areas that are in need for improvement, they also found many areas of excellence, and still more areas that they consider to be best practice, including:

- · Safe surgery checklist board in the OR.
- · Medical Staff Office credentialing processes.
- Antibiotic Stewardship Program.
- Neonatal Abstinence Syndrome (NAS) Program.
- NICU Clinical Alarm Fatigue Failure Mode Effects Analysis (FMEA).
- Domestic violence screening.
- Rounding process for early identification and resolution of medical equipment issues.
- · Simulation Center Program.

The surveyors also noted the prevailing sense of staff readiness, calm, and willingness to participate during this survey. Congratulations on a job well done!

Anchor 🗓 Earlier this month, The Huffington Post ran a feature story about communities around the country launching new programs modelled after TPC's AnchorED, which sends trained recovery coaches to hospital emergency departments when they admit someone who has experienced an overdose. New York City and communities in Massachusetts, Connecticut, New Hampshire, and New Jersey have created similar programs, while officials in at least seven other states—California, Maine, North Carolina, Ohio, Oklahoma, Texas, and Vermont—have been talking to AnchorED staff over the last year about starting programs in their states.

New federal funding available through the Comprehensive Addiction and Recovery Act and the 21st Century Cures Act has stimulated the development of these new responses to the overdose epidemic affecting communities across the country.
