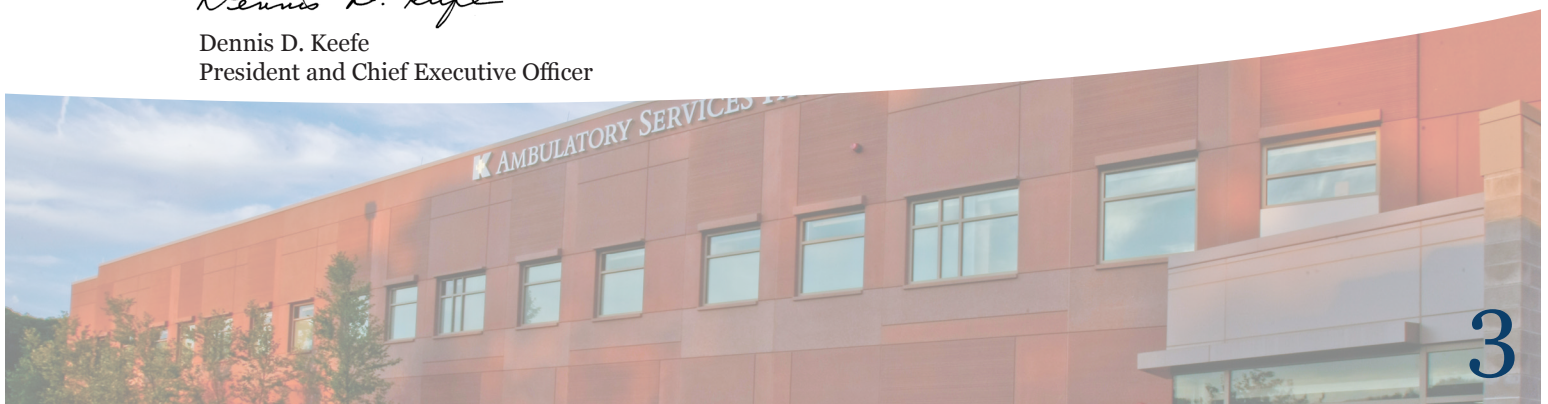

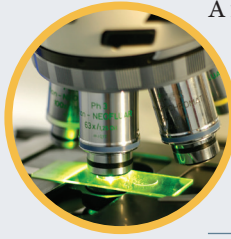

Butler Hospital research achieves “most cited” milestone



A research article published in *PLOS One* on January 25, 2012, and authored by Butler Drs. Audrey R. Tyrka, Lawrence H. Price, Oakland C. Walters, and Linda L. Carpenter, along with Carmen Marsit, just reached the top one percent of the journal’s “Most Cited Articles.” The article, titled “Childhood Adversity and Epigenetic Modulation of the Leukocyte Glucocorticoid Receptor: Preliminary Findings in Healthy Adults” as of June 2017 has been viewed 14,304 times and cited 180 times. Additionally, the PDF of the article has been downloaded 2,841 times. This is another example of the impact Butler Hospital’s research has locally, regionally, nationally, and internationally.

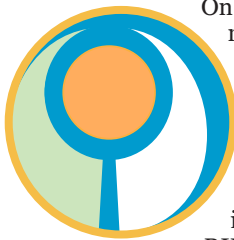
Jessica Vick, RN, receives DAISY Award

TPC’s Consumer Advocacy Council Awards recognize client successes



On June 21, The Providence Center (TPC)’s Consumer Advocacy Council (CAC) held their annual recognition awards ceremony to celebrate the hard work and progress of TPC clients. Clients are nominated for the awards by staff, and 15 honorable mentions were presented, along with three awards: Community services achievement, Outstanding Progress in Recovery, and Long-term Achievement.

The CAC is a group for TPC clients led by staff liaisons that is designed to examine issues pertinent to clients and increase advocacy efforts. They have been involved in voter registration initiatives, Rally for Recovery at the State House, and most recently, advocacy surrounding RIPTA’s proposed changes to the no-fare passes for disabled individuals. Epic/Cerner upgrades planned for July 22 and 23

Planned upgrades for Epic and Cerner will require a downtime for both systems on Saturday, July 22 and Sunday, July 23. The downtime for Epic will begin at 2 p.m. on July 22 and is expected to be ready for live use on Monday, July 24; the Cerner platform will go offline beginning at midnight on July 23 and is expected to be ready to use by 6:30 a.m. that morning.

The upgrade from Epic 2014 to Epic 2017 includes a significant change in the user interface, highlighted by a more intuitive workflow expected to reduce “clicks” by 25 percent. The Cerner upgrade will result in fewer modifications to the look and feel, but includes new templates as part of the platform’s “Dynamic Documentation” for providers. While an SRO (Support Read Only) version of Epic will be available during the upgrade, standard downtime procedures should be implemented for both systems.
