If this work stoppage occurs, you can expect continuous communication from both Care New England and your own operating unit operations team.

These next few weeks could be challenging in hospitals across our state, and I appreciate your diligence, patience, and unwavering commitment to our patients and each other. You always rise to the occasion, and I know this will be no different as we all come together for the health and wellness of our community.

Take advantage of Care New England library services



A few months ago, we sent out a system wide survey soliciting your questions and feedback about our library services. We heard from a variety of staff members, from physicians and pharmacists to students and researchers. While we did receive many positive comments, we found that some employees didn't know much about what we offer, or weren't even aware of the services. CNE offers a variety of print and electronic library resources and services that are available to all CNE medical/clinical staff, residents, and students on rotation. Some of the more commonly-used subscriptions we have available are:

- PubMed
- Cumulative Index of Nursing and Allied Health Literature (CINAHL)
- Up to Date
- New England Journal of Medicine

CNE's health sciences librarian, Arline Dyer, BSN, MLIS, has a background in the medical field. After many years as a registered nurse, Dyer wanted to go to law school but became more interested in library science after working part-time in a law library. "I enjoy being able to contribute to quality clinical care by providing access to up-to-date information," said Dyer. "I want people to be aware of all the resources that we have available, and know that educational resources aren't just for doctors. I encourage all medical staff members to seek out the latest research in their field." Dyer is available to assist employees with:

- Interlibrary loans for books and articles
- Access to online resources
- · Literature searches
- Individual instruction on database searching
- Access to computer, copier, fax, scanner


