Mental Health Association of RI launches Parity Initiative



Governor Raimondo, consumers, advocates, and professionals from Rhode Island's behavioral health community all gathered at Butler recently for a Mental Health Association of RI (MHARI) event launching an important and long-overdue campaign to help Rhode Islanders assert their rights under mental health parity laws. The RI Parity Initiative (RIPI) is a public awareness effort to educate and empower people to understand and assert their rights to health insurance coverage for mental health, including addiction, treatment, and services.

"We should all be proud that Butler was selected as the site for the kickoff of this important campaign. The stigma around mental health, both in the

community at-large, and just as importantly with the insurance companies themselves, has been slow to change, and there is still much work to be done. There is no reason, particularly in 2018, that people seeking mental health or addiction services should experience discrimination of any kind," said Mary Marran, president and chief operating officer, Butler Hospital. The RI Parity Initiative will work to educate and inform Rhode Islanders about the rights we all have to ensure health plans cover mental health services the same way they do medical and surgical services.

Earlier this year Governor Raimondo signed an executive order reaffirming and expanding Rhode Island's commitment to people with mental health and substance use disorders while addressing access to timely and needed care. The kickoff of the RI Parity Initiative is an important step towards lessening the stigma within our communities while ensuring a level playing field when patients need access to high-quality, affordable behavioral health services. The Governor, the Rhode Island Department of Behavioral Health, Developmental Disabilities & Hospitals, the Rhode Island Foundation, and the United Way of Rhode Island should all be applauded for their continued focus on these critical issues. Anchor Recovery Center to move to temporary location

Due to the sale of the building, Anchor Recovery Center in Pawtucket will be moving out of its current space before the end of the year and into a temporary location at the Jim Gillen Teen Center, located at 1280 North Main Street in Providence. Community groups that use Anchor for weekly meetings are arranging alternate sites until Anchor finds a permanent home.

The following Anchor Pawtucket services will be available at Anchor's temporary location:

- · Recovery coach services
- Employment services (public computers will be available for job-specific activities)
- Education
- All recovery support meetings
- Homecomers' groups
- · Women's group
- Arts and crafts groups
- Some volunteer services



Given the limited space at the Teen Center, Anchor will not have the space for members to use public computers or phones, or for any purpose outside of the activities listed above.

Anchor management, with the help of TPC and Care New England Facilities departments, is in the process of searching for a permanent location in the area.
