In other exciting and important news, we will be releasing our FY 2018 Q3 financials later today. Briefly though, I am happy to report that the Obligated Group—I know everyone knows from our Town Hall meetings that this is all of the CNE operating units excluding Memorial—has seen six consecutive months of positive gains from operations totaling \$9 million. For Q3 alone, the group has achieved a \$4.6 million gain from operations. When you factor in Memorial, CNE as a whole has achieved a positive gain of \$.8 million from operations.

I am also pleased to tell you the most recent Fitch Ratings Report has affirmed our BB rating while revising our rating outlook to positive. This is clearly an acknowledgement of all of your hard work! We can't ease up now, but it is something we should all be proud of.

Finally, as I mentioned in my Operations Message last week, we continue to move the process forward with Partners. We are diligently preparing filings to begin the regulatory process. More to come on those details in the days ahead.

In closing, thank you for helping make all these accomplishments possible! Thank you for coming to our Town Hall meetings and for speaking up! I appreciate your involvement, feedback, and tremendous work.

#### Congressman Langevin visits Kent Hospital

### Anchor director participates in Washington, DC recovery panel



Recently, Deb Dettor, director of Recovery Support Services for The Providence Center's Anchor Recovery Centers, was selected to participate in a first-of-its-kind national research advisory panel in Washington, DC. The Technical Expert Panel on Research and Evaluation for Recovery Support Services was set up so that the Substance Abuse and Mental Health Services Administration (SAMHSA) and other national funders could receive input from national experts in the recovery field. The panel was facilitated by John Kelly, PhD, ABPP, from the Harvard Medical School and

Recovery Research Institute, and Tom Hill, MA, from the National Council for Behavioral Health.

Dettor was asked to present on recovery community centers. "I was greatly honored to be invited to speak, and was able to forge connections with researchers who are excited about Anchor's work and are interested in studying Anchor program outcomes." said Dettor. With programs like Anchor ED (recovery coaching in hospital emergency rooms), MORE (mobile outreach recovery coaching), and Department of Corrections-based recovery coaching, Anchor is viewed as a national leader in the peer recovery field.

"Perhaps most promising about recovery support services is that they lead to better recovery outcomes with a significantly lower price tag," said Dettor. "Current research indicates that 50 to 60 percent of individuals suffering from addiction will achieve full sustained remission, and studies are underway to determine how the use of community-based recovery support will improve this statistic."
