Congratulations to the VNA's Brenda Vanner



Congratulations to Brenda Vanner, BSN, RN, nurse case manager at the VNA of Care New England, who has successfully completed the Certified Diabetes Outpatient Educator (CDOE) certification program through the Rhode Island CDOE organization. The course, which is 32 hours in length and requires the passing of an exam for certification, provides advanced diabetes education to nurses, nutritionists, and pharmacists who are passionate about improving the lives of patients with diabetes.

Approximately 9.4 percent of the U.S. population is living with diabetes, including many patients who are cared for by the VNA. People with diabetes are not only in need of expert education; they also require significant support to be able to achieve their goals related to diet, medication management, and exercise.

The certification program also encourages educators, like Brenda, to collaborate with other professionals and share best practices. She intends to use her certification to improve outcomes for the patients at the VNA, stating that "Diabetes is not an individual problem, it's societal." Brenda has been employed by the VNA since 2017 and is a graduate of the VNA's Home Care Nurse Residency Program for new graduate nurses.

Annual system-wide mandatory education

Care New England is introducing a system-wide core curriculum for annual mandatory education, also known as "mandatories," through the <u>HealthStream</u> learning management system.

This core curriculum will apply to all CNE operating units and include modules in the following subject areas: Safety, Quality, Risk, Infection Prevention and Control, Human Resources, HIPAA & Compliance, and Environment of Care. **The core curriculum were assigned on June 1, 2019 with a completion date of November 30, 2019.** We recommend you pace yourself, please do not let the marathon become a sprint; you have six months to complete all assignments.

Most courses will now include a pre-assessment to provide workforce members with strong existing knowledge of a subject area an opportunity to "test out" of a course if passed with an 80 percent or higher on the first attempt. There may also be some operating unit-specific or role-based courses not included in the system-wide core curriculum that will be assigned separately. Butler Hospital will continue to its practice of conducting an annual Education Fair, covering the same curriculum.
