ACTivity Message from Bob Haffey, MBA, MSN, RN, president and COO, Kent Hospital:

While at work on the morning of Wednesday, April 3, Jo-Anne Gannon, 61, from Coventry, began experiencing severe chest pains and was quickly brought to Kent Hospital's Emergency Department. Once at Kent, after initial and subsequent testing, Gannon was admitted. Unfortunately, her symptoms worsened and a rapid response was called. Due to the fast actions and attentiveness of our staff, she was treated and recovered and was closely monitored in the Progressive Care Unit throughout the night.

Select Care New England hospitals hold local farmer's markets as part of Sodexo's Local Produce Sourcing Commitment initiative



This past November, Sodexo held a local produce up-scale event for the Massachusetts and Rhode Island food system constituents. From the connections made at this event, Sodexo's New England Regional Leadership Team agreed to conduct a local sourcing pilot across the health care and university segments of Sodexo for 17 select accounts in 2019, which includes Kent, Butler, and Women & Infants hospitals.

The pilot seeks to achieve 10 percent locally grown, raised, or cultivated produce for overall produce purchases, prioritizing state-grown produce for each account.

Working with Farm Fresh RI, a nonprofit organization in Rhode Island, Sodexo's Care New England team has joined in Sodexo's 2019 Local Produce Sourcing Commitment.

Led by Mandilyn Beck, sustainability director, Sodexo at Partners HealthCare, our Care New England team members include Chris Minutoli, operations manager, Women & Infants; and Joshua Napolitano, food production manager, Kent Hospital. Other members of this initiative include representatives from the Rhode Island Commerce Corporation, Health Care Without Harm, Rhode Island Department of Environmental Management, Supply RI, and the Rhode Island Governor's Office.

From March through May, this task force met regularly to identify key local products that are best suited for use in Rhode Island institutional markets, based on local supply and institutional demand. Kent has already begun sourcing from Farm Fresh RI to hold bi-weekly farmer's markets running every other Thursday starting June 6, with Women & Infants soon to follow. Please keep an eye out for these markets and stop by in support of this local initiative.

Update on Kent Hospital's OR improvement initiative

Over the last several months, Melissa Murphy, MD, MPH, surgical director of quality and operations; and Shannon Sullivan, MSW, LICSW, CCM, vice president of operations, have shared the initiatives staff has taken to improve the culture and efficiency of Kent ORs.

Over the past six months, there has been a dramatic change in the following key metrics:

- First cases with on-time starts have risen by 23 percent over last year.
- All cases with on-time starts have risen by 20 percent over last year.
- Turnover time in the main OR has dropped by 18 percent.
- Cancellations for the OR within 24 hours have dropped by 50 percent.
- Utilization of the ORs in the evening hours has dropped from 45 percent to 15 percent. This is largely due to our efforts to improve efficiency, as well as our ability to receive more cases during the day.

In addition, the month of May saw the largest volume on record throughout the ORs. This success speaks to the great team and the efforts they have been making to establish Kent as a Highly Reliable Organization (HRO) and one of the best places to have surgery in the region.

Annual system-wide mandatory education

Care New England is introducing a system-wide core curriculum for annual mandatory education, also known as "mandatories," through the <u>HealthStream</u> learning management system.

This core curriculum will apply to all CNE operating units and include modules in the following subject areas: Safety, Quality, Risk, Infection Prevention and Control, Human Resources, HIPAA & Compliance, and Environment of Care. **The core curriculum was assigned on June 1, 2019 with a completion date of November 30, 2019.** We recommend you pace yourself, please do not let the marathon become a sprint; you have six months to complete all assignments.

Most courses will now include a pre-assessment to provide workforce members with strong existing knowledge of a subject area an opportunity to "test out" of a course if passed with an 80 percent or higher on the first attempt. There may also be some operating unit-specific or role-based courses not included in the system-wide core curriculum that will be assigned separately. Butler Hospital will continue to its practice of conducting an annual Education Fair, covering the same curriculum.
