Congratulations to Women & Infants and Butler Hospital physicians for recently being recognized for their groundbreaking research in the fields of both urogynecology and suicide prevention. This represents an important and growing list of distinctions that CNE researchers continue to achieve. We are grateful and most appreciative to all of our researchers for the important work they are doing on a daily basis.





Vivian Sung, MD, MPH, FACOG, of the Division of Urogynecology and Reconstructive Pelvic Surgery and professor at The Warren Alpert Medical School of Brown University, was instrumental in two groundbreaking research trials conducted through the Division of Urogynecology and Reconstructive Pelvic Surgery at Women & Infants and has recently been published in the Journal of the American Medical Association (JAMA).

The first is titled, Effects of Surgical Treatment Enhanced with Exercise for Mixed Urinary Incontinence (the ESTEEM trial). The second, co-authored with Women & Infants colleague, **Charles Rardin, MD, FACOG** of the Division of Urogynecology and

Reconstructive Pelvic Surgery and professor at The Warren Alpert Medical School of Brown University, compares two different surgical treatments for uterine prolapse (the SUPeR trial). To see both articles in their entirety, please visit jamanetwork.com.

Anchor Recovery Center's Ryan Duxbury leads a panel discussion on opioids in the community



On Thursday, September 19, Ryan Duxbury, assistant manager of Anchor ED, led a panel discussion on opioids in the community, which was presented by Rhode Island PBS. The event took place at the WaterFire Arts Center on Valley Street in Providence, as part of recovery month activities for the state. He spoke about the wrap around services provided by Anchor Recovery, including Anchor Center, Anchor Warwick, AnchorED, AnchorMORE, Safe Stations, Anchor Teen, employment services, and volunteer opportunities. He also discussed the many ways in which these programs help

combat the current substance use crisis by building recovery capital and discussed the ways in which the role of a peer recovery coach is to motivate individuals through the stages of change.

"At Anchor we believe peer support can lead people to recovery. We have a safe and supportive environment that connects individuals with the community. That connection, in turn, will help put an end to this epidemic," stated Ryan.


