The Access Center, led by Director, Gail Fugere, under the advisement of Alyscia Grant, chief access officer, will be open Monday through Friday from 7 a.m. to 6 p.m. and Saturdays from 8 a.m. to 12 noon.

As we introduce our system-wide Access Center, it's also important to remind you that Butler Hospital has its own centralized Behavioral Health Intake Center with staff available 365 days a year, 24 hours a day, and seven days a week. This call center helps individuals who are in crisis or need information about Butler's treatment options. Patients can reach that call center at 1 (844) 401-0111, or by calling (401) CareNow and selecting option 4.

### Butler Hospital's adolescent and young adult services to be featured on WPRI-TV's 12 on 12 digital original series

WPRI-TV's Danielle North is working on an extended television piece for her 12 on 12 digital original series for the month of March. The segment will focus on teens and mental health, dealing with isolation, and social media issues. The Centers for Disease Control and Prevention (CDC) reports that suicide is the second leading cause of death among adolescents. Danielle visited Butler Hospital recently to visit the adolescent partial hospital program and film and conduct interviews with Gerrit VanSchalkwyk, MD, chief of adolescent and young adult services, and Erin Ursillo, LMHC, director of young adult partial hospital program.

Both experts discussed their clinical experience with groups who are at high risk for suicide or suicide attempts, including gender diverse youth.

She told her story through the use of a translator and spoke about the fear she felt for herself and her baby and how grateful she was for the compassionate and specialized care she received from both the Division of Maternal-Fetal Medicine and the Breast Health Center.

It was the care of both of these programs, she said, that gave her hope. Gardenia recently had a healthy baby boy and is currently receiving treatment through our Breast Health Center.

## CARE NEW ENGLAND

### Care New England announces the opening of its Pulmonary Nodule Clinic

The primary function of this clinic, which opened in December 2019, is to achieve timely evaluation of patients with lung nodules detected incidental to CT scans, non-screening x-rays, or through low dose lung cancer screening CT's. During the patient visit, the doctor will perform a physical exam, review images, analyze PFT results, and decide the best approach for further evaluation. He or she will then make referrals to interventional radiology, thoracic surgery, and oncology. Patients can be referred from emergency rooms, clinics, community health centers, and private offices. Complex cases will be presented at the pulmonary tumor board when appropriate.

A nurse navigator is available to provide support to the patient from time of referral throughout the process of diagnosing or ruling out cancer, and is on-site during the pulmonary consult to coordinate care. They will also provide guidance to the primary care physician and will triage patients needing an urgent pulmonary consult. ## Kent Hospital joins the American College of Surgeons' Geriatric Surgery Verification Program

As the national movement to drive improved quality of care for older adults, and the push to encourage health systems in the work of becoming Age Friendly takes hold, the American College of Surgeons (ACS) has joined in and announced a program to help distribute the best practices and gold standards of care for taking care of older adults undergoing surgical procedures.

According to the ACS, this new program presents 32 new surgical standards designed to systematically improve surgical care and outcomes for the aging adult population. The standards provide a framework for hospitals to take an interdisciplinary approach to continuously optimize surgical care for older adults.

The standards for the [Geriatric Surgery Verification \(GSV\) Program](#) are made up of several facets, of which include:

1) Institutional Administrative Commitment; 2) Program Scope & Governance; 3) Facilities & Equipment Resources; 4) Personnel & Services Resources; 5) Patient Care: Expectations & Protocols; 6) Data Surveillance & Systems; 7) Quality Improvement; 8) Education: Professional & Community Outreach; and 9) Research: Basic and Clinical Trials.

Kent has committed to pursue this initiative and has formed a Geriatric Surgery Quality Committee to implement the standards and work toward the verification. Among this committee includes Ana Tuya Fulton, MD, AGSF, FACP, executive chief of geriatrics and palliative care; Melissa Murphy, MD, MPH, surgical director of quality and operations; and Shannon Sullivan, MSW, LICSW, CCM, vice president of operations. Stay tuned for updates on the implementation of this new program and how we will be able to begin providing an improved level of care to the older adults in our community.
