of our anniversary, we launched "Gowrie NSW: Celebrating 75 years", a history book written by Associate Professor Frances Press and Dr Sandie Wong celebrating the passion and commitment of all Gowrie educators. The book documents our journey since founding, and enables us to share how our organisation has changed over time, from a single demonstration child research centre to an entity managing and supporting a diverse and dynamic range of programs for children, families and sector professionals across NSW and the ACT

Such a significant occasion gave the Board an opportunity to pause and reflect. We are very proud of our history and our journey over the past 75 years. In April 2016, Gowrie NSW celebrated the opening of our newest earlychildhood centre, in Mudgee. The long-awaited centre offers 40 new placements for 3- to 5-year-olds in a region that has been dealing with a shortage of preschool places.

The opening of Gowrie NSW's Mudgee centre was a milestone for our organisation, as this is our first in the area, although we have been supporting children and families in Mudgee through government programs for the past 10 years. Deputy Premier Troy Grant, Minister for Early Childhood Education Leslie Williams and Mayor for Mid-Western Council Des Kennedy attended the opening, giving our state-of-the-art centre their tick of approval.









The children of Gowrie NSW OSHC Erskineville unveiled a 'totem' created for Erskineville Public School through an artist in residence program in November 2015.

The artist in residence program was an opportunity for the children who attend Gowrie NSW's Outside School Hours Care to design and create individual artworks with guidance from visual artist Philippa Playford. The individual artworks were arranged together to form a grouping of totems and were unveiled at a special celebration.

The interest in totems stemmed from a group investigation into how Indigenous Australians and other cultures use totems as part of their spiritual identity. While participating in the project, the children considered signs and symbols of their culture, personal identity and community experiences to reflect in their individual pieces.

The artist in residence project enabled children to explore the various techniques used in clay work including hand forming, carving & building.

The result, a colourful ceramic art piece which now stands in the grounds of Erskineville Public School as a symbol of community, connection and collaborative relationships with children.











Year at a glance

- In honour of our 75th anniversary, Gowrie NSW employees and notable guests were invited to attend an anniversary ball at The Ivy in the Sydney CBD.
- Gowrie NSW was successful in tendering for a project with the Department of Health to identify and develop the 'Munch & Move' learning resource for the vocational and tertiary training sector.
- In the past 12 months Gowrie NSW witnessed a substantial growth in consultancy requests, with a focus on mentoring for supervisors and educational leaders across early education and care.



Gowrie NSW are knowledge leaders within the early education sector, holding two highly successful conferences during 2015 and 2016.

In April 2016, "Down the Rabbit Hole: A festival of bold childhood ideas" conference was held at the NSW Art Gallery. The gathering was unique, stimulation of the senses with a feast of ideas to challenge those who attended.

The "Infants and Toddlers: Practice, Pedagogy & Research" conference, held in September 2015, was a partnership with Macquarie University. The conference featured international speakers Dr Jayne White (NZ) and Dr Jools Page (UK) - who spoke about their latest research around infants and toddlers and practical strategies for early-childhood educators - reflecting our goal to lead within the infant and toddler space.









Child and Family Information Line

Gowrie NSW operates the Child and Family Information Line, a NSW State Government-funded project providing a telephone referral service to support families throughout the state. As part of the project, Gowrie NSW maintains an extensive database of childcare centres, government agencies and support services.



Adult Migrant English Program (AMEP)

Gowrie NSW in partnership with TAFE NSW and NSW AMES provides child care for the Adult Migrant English Program (AMEP). Gowrie NSW places children aged 6 weeks to 5 years in mainstream child care centres and crèche programs while their parent studies English. In 2015/16 AMEP received 3,414 referrals in total.




Gowrie NSW has been providing inclusion support to education and care centres for many years and our commitment to inclusion continues under the Inclusion Support Programme (ISP) which commenced in July 2016. The program has undergone significant changes over the past years and is now a key component of the federal governments "Jobs for Families Package", This coincides with the government's commitment to increased workforce participation for families and a stronger focus on building services capacity to include children with additional needs and providing them with greater opportunities to learn and develop.

Gowrie NSW will be delivering the ISP in partnership with KU Children's Services and Include Me in NSW and the ACT.

- The provision of specialised playgroups supporting families in a sensitive observation environment and understanding of their child's natural development.
- The growth and expansion of crèche placements, supporting culturally and linguistically diverse children.
- Continued, highly regarded conferences, further establishing Gowrie NSW as reputable knowledge leaders within the sector.
- Building partnerships to grow research capacity to develop positive long-term outcomes for children in the early years.

At Gowrie NSW, we are gearing up to ensure our next 75 years are as significant, sustainable and successful as our first 75 years.




Gowrie NSW Surplus


