Inactive Ingredients

Sodium benzoate, citric acid, sodium citrate, glycerin, ethyl p-hydroxybenzoate, polyoxyethylene hydrogenated castor oil, flavor, acesulfame-K, sucrose esters of fatty acids, sucralose, polyglyceryl monostearate, medium chain fatty acid triglyceride, dextrin, trehalose, white soft sugar, povidone, starch syrup, DL-malic acid (alcohol content no more than 0.49 mL)

Precautions for Ingredients

Taking this medicine may cause urine to turn yellow, but this is due to assimilation of the vitamin B₂ contained in the medicine, with part of it being excreted in the urine. It is not a cause for concern.

Consultation Needed for These Cases

1. In the following cases, immediately discontinue the use of this medicine and consult a physician or pharmacist, being sure to take this medicine with you.

- (1) If the following symptoms are observed after taking this medicine

Parts affected	Symptom
Skin	Rash
Digestive organs	Stomach discomfort

- (2) When symptoms do not improve even after using the medicine for a while

2. The following symptoms may be observed after taking this medicine. If these symptoms persist or worsen, discontinue the use of this medicine, and consult a physician or pharmacist.

Diarrhea

Precautions for Storage and Handling

1. Store sealed in a cool place away from direct sunlight.
2. Keep out of reach of children.
3. Do not transfer to a different container. (It may lead to misuse or alter the quality.)
4. Due to the crude drug extracts contained in this medicine, cloudiness may be observed; however, there is no change in the effects.
5. Do not take medicine that has exceeded its expiration date.
