#### Indications

#### Dosage and Administration

Take the following dosage orally with cold or hot water.

Adult (15 years or older)	2 tablets	Twice a day
Child (Under 15 years)	Do not take this medicine	

## Active Ingredients and Actions

The daily adult dose of 4 tablets contains the following active ingredients.

Ingredient	Amount	Action
Riboflavin Sodium Phosphate (Vitamin B <sub>2</sub> phosphate ester)	15 mg	• Aids fat metabolism, converting it to energy.
Pyridoxine Hydrochloride (Vitamin B <sub>6</sub> )	15 mg	• Aids protein metabolism, converting it to energy.
Thiamine Nitrate (Vitamin B <sub>1</sub> nitrate)	10 mg	• Aids carbohydrate metabolism, converting it to energy.
Royal jelly tincture (equivalent to 100 mg of natural royal jelly)	100 mg	• Contains the 3 main nutrient classes (proteins, carbohydrates and fats) along with a well-balanced mixture of various vitamins and minerals.
Taurine	1000 mg	• Involved in the generation of needed energy when fatigued.
Nicotinamide	20 mg	• A coenzyme that acts in the process of generating energy from nutrients.
Anhydrous caffeine	50 mg	• Exhibits excitatory effects on internal organs, making it harder for fatigue to persist.

### Inactive Ingredients

Talc, corn starch, partly pregelatinized starch, titanium oxide, red ferric oxide, magnesium stearate, cellulose, hypromellose, povidone, macrogol, dibasic calcium phosphate

### Precautions for Ingredients

Taking this medicine may cause urine to turn bright yellow, but this is due to assimilation of the vitamin B<sub>2</sub> contained in the medicine, with part of it being excreted in the urine. It is not a cause for concern.



### Precautions

#### Consultation

- If the following symptoms are observed after taking this medicine, these may be adverse reactions. Immediately discontinue the use of this medicine and show this informational leaflet to a physician, pharmacist or registered salesperson for a consultation.

Parts Affected	Symptom
Skin	Rash
Digestive organs	Stomach discomfort

- The following symptom may be observed after taking the medicine. If this symptom persists or worsens, discontinue the use of this medicine show this informational leaflet to a physician, pharmacist or registered salesperson for a consultation.

Diarrhea

- If symptoms do not improve even after taking the medicine for about 1 month, stop taking the medicine and consult a physician, pharmacist or registered salesperson, bringing this informational leaflet with you.

### Precautions for Storage and Handling

1. Store sealed in a dry, cool place away from direct sunlight.
2. Keep out of reach of children.
3. Do not transfer to a different container. Also, do not transfer other medications, etc., into this container. (It may lead to misuse or alter the quality.)
4. Moisture may alter the outer appearance of the tablets, so do not handle with wet hands.
5. The packing material inside the container is provided to prevent damage to the tablets during transport. After opening the cap, discard the packing material.
6. A desiccant is included in the container. Do not ingest the desiccant.
7. Do not take tablets that have exceeded their expiration date.
8. From the standpoint of maintaining quality, as a rule of thumb, once the cap has been opened, use the tablets within 6 months, regardless of their expiration date. There is a space marked "Date Opened" on the box's inner flap. Please use that to record the date of opening.
