# **Bring Your Dog To Work**

The Designers Guild Building (DGB) is a pet-friendly business environment and individuals working in the building are welcome to bring their dogs to work with them. - You must submit an annual application and registration form to building management and await approval from the Landlord prior to bringing your dog into the building. Applications can be submitted via email to lisa.sherman@ngkf.com.
- Dogs must always be kept on a leash when on DGB property.
- Pet owners must immediately pick up and dispose of all pet waste.

#### **COVID-19 Updates**

• Effective July 25th, Governor Walz issued a statewide mask mandate requiring masks in all public indoor spaces and businesses, unless you are alone or meet exemption criteria.

In accordance with Executive Order 20-81, face masks will be required at DGB indefinitely, but face masks will not be policed by building management. The City of Minneapolis has directed calls to 311 for assistance.
