This addendum modifies the drawings and specifications as follows:

- b) Paragraph 1.4 E.: STRIKE "Final Completion of all work including punch list items shall be no later than (two) weeks after the date established as the Date of Substantial Completion". REPLACE with "Final Completion of all work including punch list items shall be by the end of day August 20, 2022"

# 4) <u>SPECIFICATION SECTION 085113 – ALUMINUM WINDOWS –</u>

- a) Paragraph 1.6 C.1.: Basis of Design Product: DELETE sub-paragraph 1. REPLACE with:
  - (i) Windows are based on Manko 3527i Series thermally-improved windows with 3.5-inch perimeter frame. Perimeter framing and operating units to match existing aluminum windows in general profiles and performance.
- b) Paragraph 2.1 B. Basis of Design Product: The Manko product listed is a discontinued series. DELETE "Manko Window systems 550 thermal Series with 4-1/16 inch deep perimeter frame." REPLACE with "Manko Window Systems 3527 Series with a (nominal) 3 ½" deep perimeter frame" fixed and project-out units."

- c) Frame depth: Nominal 3-1/2 inches.
- d) **DesCo i65 Series Thermal** is approved as an equal Basis of Design product.
- e) Other manufacturer's products may be submitted for substitution approval contingent upon conformance with the all requirements listed in the Contract Documents and approval of architect.

#### Introductions

- 1. Review of Project Scope Jordan Burbach
  - a. Demolition, remodel of second floor classrooms
  - b. West, south window replacement
  - c. Alternate bid item two first floor classroom remodel
- 2. Davis-Bacon wage rates, payroll reporting, summary of requirements Jennifer Sietsema, BHCLG:
  - **a.** Compliance with the Davis-Bacon Act will be required for this project. The wage rates and payroll reporting information are included in the Project Manual.
  - b. BHCLG staff are working for the School District, will be available to help contractors with payroll submittals, other requirements.

- c. BHCLG will be administrating by DOE rules. More detailed information will be presented at the Pre-Construction meeting.
- d. Additional wage classifications other than listed in Project Manual must be filed separately. Extra time must be allowed for processing submissions. BHCLG has the forms, will assist.
- e. If Union workers are used and fringe benefits are included to make wage rate, employees must declare them as income.
- f. Certification, apprenticeship program for Electrical & Plumbing be aware that SD does not recognize all programs being used as meeting Federal requirements.
  - i. Apprentices are required to be paid full wage as per the wage rates for their respective trades.
- g. Payroll reports are required to be submitted weekly for this project. Jennifer recommends contractor submit first report ASAP so any deficiencies can be corrected for subsequent reports.
- h. BHCLG will conduct on-site employee interviews to verify wage rates are being paid.
- i. Regarding Section 3 Additional Training/Certification requirements in D-B: BHCLG will use the simplified version no CDBG requirements. Or additional training required at this time.
- j. Regarding HUD-level requirements: BHCLG does not have clarification yet; assume not required.
- k. BHCLG will accept all formats for submissions if all required information is included.
- 3. Contract documents have been reviewed by DOE third-party and revised accordingly. Architecture Incorporated received notification of full compliance with ESSER requirements.
- 4. Review of Project Schedule Jordan Burbach, Brett Burditt
  - a. Bid Opening January 6, 2022, 2:00 pm MT, Williams Administration Building. A Zoom meeting may be set up to allow remote viewing. Details will be included in an addendum.
  - b. Board meeting week of January 10 to award contract. Contractor should expedite shop drawings, ordering, storage for critical-path materials immediately, as this is a short construction schedule. The School will provide on-site secure storage, access, etc.
  - c. Site is available May 25<sup>th</sup>, but earlier work can start on the west side rooms that are not being used for classes. There is flexibility for both start and finish of work in these areas.
  - d. Completion dates given in Project Manual will be revised in Addendum #1: Substantial Completion is to be August 12, 2022; 100% completion to be August 20, 2022.
  - e. Staging area in parking lot between R.B. Williams and the MS gym will be available for duration of project, including during the Rally.
    - i. 2022 Sturgis Rally dates are: August 5-14.
- 5. Walk-through of building areas included in project:

- a. All asbestos abatement by owner will be complete by start of project.
- b. Viewed above-ceiling condition of structural wall in E207/E208 to be removed. Architect has photos available by request.
- c. Replacement carpet will be all new material shelf stock not available.
- d. Roof was accessed for review of conditions.
- e. Aluminum replacement windows: Window type to be revised and clarified in Addendum #1. Previous replacements were done approximately 10 years ago and 5 years ago. The intent is to match those framing profiles as much as possible, although information on the systems used is not available. Substitution requests are welcome.
- f. Louvers shown in first floor windows are for Alternate #1 only. Those sections to be spandrel glazed for Base Bid.
- 6. Addendum #1 will be issued on Wednesday, December 29, 2021. Contractor questions brought up during the Pre-Bid meeting will be addressed, and an updated Plan Holders list included.
